WHEREAS, Ordinance No. 2025-19 dated November 11, 2025 of the City of Bislig, this Province entitled “An Ordinance Creating the City Agriculture and Biosystems Engineering Office (CABEO) of the City of Bislig and its Relevant Position Titles, Determining its Powers, Duties and Functions and Providing Funds Thereof”, was submitted to this Body for review and same was referred to the Committee on Good Government, Public Ethics and Accountability, for appropriate action and was indorsed the Provincial Finance Committee (PFC) and to the Provincial Human Resource Management Office (PHRMO), for technical review;
