AFFIRMING ORDINANCE NO. 2025-13 DATED SEPTEMBER 23, 2025 OF THE CITY OF BISLIG, THIS PROVINCE ENTITLED "AN ORDINANCE CREATING THE POSITION OF LOCAL REVENUE COLLECTION OFFICER IV, SALARY GRADE 22, UNDER THE OFFICE OF THE CITY TREASURER, AND APPROPRIATING FUNDS THEREOF", IT BEING WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNANG PANLUNGSOD CONCERNED TO ENACT SUCH ORDINANCE PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991

WHEREAS, Chapter 3, Article III, Section 486, Par. (a) No. 1 (i) of the Local Government Code of 1991 provides that, "the Sangguniang Panlalawigan shall review all ordinances approved by Sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the Sanggunian and of the Mayor";

WHEREAS, Ordinance No. 2025-13 dated September 23, 2025 of the City of Bislig, this Province entitled "An Ordinance Creating the Position of Local Revenue Collection Officer IV, Salary Grade 22, Under the Office of the City Treasurer, and Appropriating Funds Thereof", was submitted to this Body for review and same was referred to the Committee on Good Government, Public Ethics and Accountability, for appropriate action and was indorsed to the Provincial Human Resource Management Office (PHRMO) and to the Provincial Finance Committee (PFC), all of this Province, for technical review;

WHEREAS, the Provincial Finance Committee (PFC) in its letter dated January 23, 2026 informed the Body that the above-mentioned Ordinance is within the scope of the prescribed powers of the Sanggunian Panlungsod concerned as outlined in Section 454 and Section 458, paragraph a(1)(viii) of R.A. 7160;

WHEREAS, Mr. Ace R. Orcullo, MPA, CHRA, Provincial Human Resource Management Officer, this Province in his letter dated February 27, 2026 upon perusal of the subject Ordinance, ~~returned the same with no adverse finding~~ and has recommended for its adoption; *found infirmity*

WHEREAS, after a careful review by the Committee to which the matter was referred to, it was found out that it is within the ambit of the provisions of the Local Government Code of 1991;

WHEREAS in view of the foregoing and on motion of _____ and duly seconded by _____;

BE IT RESOLVED by the Sangguniang Panlalawigan of Surigao del Sur to affirm Ordinance No. 2025-13 dated September 23, 2025 of the City of Bislig, this Province entitled "An Ordinance Creating the Position of Local Revenue Collection Officer IV, Salary Grade 22, Under the Office of the City Treasurer, and Appropriating Funds Thereof", it being within the scope of the prescribed powers of the Sangguniang Panlungsod concerned to enact such Ordinance pursuant to the Local Government Code of 1991.
