AFFIRMING ORDINANCE NO. 40-B DATED OCTOBER 20, 2025 OF THE MUNICIPALITY OF CARRASCAL, THIS PROVINCE ENTITLED "AN ORDINANCE CREATING THE POSITION OF INTERNAL AUDITING ASSISTANT, SALARY GRADE 8, UNDER THE INTERNAL AUDIT SERVICE OFFICE OF THE MUNICIPALITY OF CARRASCAL, PROVINCE OF SURIGAO DEL SUR, AND PROVIDING FUNDS THEREFOR", IT BEING WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNIAN BAYAN CONCERNED TO ENACT SUCH ORDINANCE PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991

WHEREAS, Chapter 3, Article III, Section 486, Par. (a) No. 1 (i) of the Local Government Code of 1991 provides that, "the Sangguniang Panlalawigan shall review all ordinances approved by Sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the Sanggunian and of the Mayor";

WHEREAS, Ordinance No. 40-B dated October 20, 2025 of the Municipality of Carrascal, this Province entitled "An Ordinance Creating the Position of Internal Auditing Assistant, Salary Grade 8, Under the Internal Audit Service Office of the Municipality of Carrascal, Province of Surigao del Sur, and Providing Funds Therefor", was submitted to this Body for review and same was referred to the Committee on Good Government, Public Ethics and Accountability, for appropriate action and was indorsed to the Provincial Human Resource Management Office (PHRMO) and to the Provincial Finance Committee (PFC), all of this Province, for technical review;

WHEREAS, the Provincial Finance Committee (PFC) in its letter dated February 5, 2026 informed the Body that the above-mentioned Ordinance is within the scope of the prescribed powers of the Sanggunian Bayan concerned pursuant to Section 447 of R.A. 7160. Furthermore, it adheres to the Local Budget Circular (LBC) No. 137, dated July 13, 2021 which provides the "Index of Occupational Services, Positional Titles and Salary Grades in the Government (IOS-LGU)", CY 2021 Edition, issued by the Department of Budget and Management, and that the said LGU has still an allowable Personal Services Cost of Php54,280,988.92;

WHEREAS, Mr. Ace R. Orcullo, MPA, CHRA, Provincial Human Resource Management Officer, this Province in his letter dated March 4, 2026 upon perusal of the subject Ordinance, returned the same with no adverse finding and has recommended for its adoption;

WHEREAS, after a careful review by the Committee to which the matter was referred to, it was found out that it is within the ambit of the provisions of the Local Government Code of 1991;

WHEREAS in view of the foregoing and on motion of _____ and duly seconded by _____;

NOW THEREFORE

BE IT RESOLVED by the Sangguniang Panlalawigan of Surigao del Sur to affirm Ordinance No. 40-B dated October 20, 2025 of the Municipality of Carrascal, this Province entitled "An Ordinance Creating the Position of Internal Auditing Assistant, Salary Grade 8, Under the Internal Audit Service Office of the Municipality of Carrascal, Province of Surigao del Sur, and Providing Funds Therefor", it being within the scope of the prescribed powers of the Sangguniang Bayan concerned to enact such Ordinance pursuant to the Local Government Code of 1991.
