AFFIRMING ORDINANCE NO. TC-037 DATED JANUARY 13, 2026 OF THE MUNICIPALITY OF HINATUAN, THIS PROVINCE ENTITLED "CREATING THE FOLLOWING POSITIONS UNDER THE MUNICIPAL MAYOR'S OFFICE: SENIOR ADMINISTRATIVE ASSISTANT I (DATA CONTROLLER IV) - SG 13, ADMINISTRATIVE ASSISTANT III (COMPUTER OPERATOR II) - SG 09, FIVE (5) ADMINISTRATIVE AIDE III (UTILITY WORKER II) - SG 03, AND ADMINISTRATIVE AIDE I (UTILITY WORKER I) - SG 01", IT BEING WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN CONCERNED TO ENACT SUCH ORDINANCE PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991

WHEREAS, Ordinance No. TC-037 dated January 13, 2026 of the Municipality of Hinatuan, this Province entitled "Creating the Following Positions Under the Municipal Mayor's Office: Senior Administrative Assistant I (Data Controller IV) - SG 13, Administrative Assistant III (Computer Operator II) - SG 09, Five (5) Administrative Aide III (Utility Worker II) - SG 03, and Administrative Aide I (Utility Worker I) - SG 01", was submitted to this Body for review and same was referred to the Committee on Good Government, Public Ethics and Accountability, for appropriate action and was indorsed to the Provincial Human Resource Management Office (PHRMO) and to the Provincial Finance Committee (PFC), all of this Province, for technical review;
