TC-040 DATED JANUARY 13, 2026 OF THE MUNICIPALITY OF HINATUAN, THIS PROVINCE ENTITLED “CREATING THE FOLLOWING POSITIONS UNDER THE MUNICIPAL ASSESSOR’S OFFICE: MUNICIPAL GOVERNMENT ASSISTANT DEPARTMENT HEAD I (MUNICIPAL ASSISTANT ASSESSOR I) - SG 22, TAX MAPPER II - SG 15, ADMINISTRATIVE OFFICER II (ADMINISTRATIVE OFFICER I) - SG 11, STATISTICIAN I - SG 11, ASSESSMENT CLERK III – SG 09, ADMINISTRATIVE AIDE VI (DATA CONTROLLER I) - SG 06, ADMINISTRATIVE AIDE IV (BOOKBINDER II) - SG04, AND ADMINISTRATIVE AIDE III (UTILITY WORKER II - SG 03”, FOR RECTIFICATION

WHEREAS, Chapter 3, Article III, Section 468 Par. (a) No. 1 ( i ) of the Local Government Code of 1991 provides that, “the sangguniang panlalawigan shall review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the sanggunian and of the mayor”;

WHEREAS Ordinance No. TC-040 dated January 13, 2026 of the Municipality of Hinatuan, this Province entitled “Creating the Following Positions Under the Municipal Assessor’s Office: Municipal Government Assistant Department Head I (Municipal Assistant Assessor I) - SG 22, Tax Mapper II - SG 15, Administrative Officer II (Administrative Officer I) - SG 11, Statistician I - SG 11, Assessment Clerk III – SG 09, Administrative Aide VI (Data Controller I) - SG 06, Administrative Aide IV (Bookbinder II) - SG04, and Administrative Aide III (Utility Worker II - SG 03”, was submitted to this Body for review and same was referred to the Committee on Good Government, Public Ethics and Accountability, for appropriate action and was indorsed the Provincial Finance Committee (PFC) and to the Provincial Human Resource Management Office (PHRMO), for technical review;

WHEREAS, the Provincial Finance Committee (PFC) in its letter dated February 9, 2026 informed the Body that the above-mentioned Ordinance is within the scope of the prescribed powers of the Sanggunian Bayan concerned pursuant to Section 447 of R.A. 7160 (Local Government Code of 1991) and that the LGU has not exceeded the allowable Personal Services (PS) limitation;

WHEREAS, however, Mr. Ace R. Orcullo, MPA, CHRA, Provincial Human Resource Management Officer, this Province in his letter dated March 10, 2026 upon perusal of the subject Ordinance, informed the August Body of the following observations, viz:
