AFFIRMING ORDINANCE NO. 71 DATED DECEMBER 01, 2025 OF THE MUNICIPALITY OF SAN MIGUEL, THIS PROVINCE ENTITLED "AN ORDINANCE ABOLISHING THE POSITION TITLE OF ADMINISTRATIVE AIDE VI (CLERK IV) SG-6 UNDER THE OFFICE OF THE MUNICIPAL MAYOR AND REALLOCATION OF ITS CORRESPONDING APPROPRIATION FOR PERSONNEL SERVICES TO FUND THE CREATION OF TWO (2) ADMINISTRATIVE AIDE II (MESSENGER), SG-2 POSITIONS UNDER THE SAME OFFICE", IT BEING WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN CONCERNED TO ENACT SUCH ORDINANCE PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991

WHEREAS, Chapter 3, Article III, Section 468 Par. (a) No. 1 (i) of the Local Government Code of 1991 provides that, "the sangguniang panlalawigan shall review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the sanggunian and of the mayor";

WHEREAS, Ordinance No. 71 dated December 01, 2025 of The Municipality of San Miguel, this Province entitled "An Ordinance Abolishing the Position Title of Administrative Aide VI (Clerk IV) SG-6 Under the Office of the Municipal Mayor and Reallocation of Its Corresponding Appropriation for Personnel Services to Fund the Creation of Two (2) Administrative Aide II (Messenger), SG-2 Positions Under the Same Office", was submitted to this Body for review and same was referred to the Committee on Good Government, Public Ethics and Accountability, for appropriate action and was indorsed to the Provincial Human Resource Management Office (PHRMO) and to the Provincial Finance Committee (PFC), all of this Province, for technical review;

WHEREAS, the Provincial Finance Committee (PFC) in its letter dated February 25, 2026 informed the Body that the above-mentioned Ordinance is within the scope of the prescribed powers of the Sanggunian Bayan concerned pursuant to Section 447 of R.A. 7160 (Local Government Code of 1991). Furthermore, based on ^{the} ~~our~~ initial review of the Municipality's FY 2025 General Fund Annual and Supplemental Budget, the Local Government Unit (LGU) still has an allowable PS Cost of ₱11,433,214.73;

WHEREAS, Mr. Ace R. Orcullo, MPA, CHRA, Provincial Human Resource Management Officer, this Province in his letter dated March 04, 2026 ~~upon perusal of the subject Ordinance, returned the same with no adverse finding~~ ^{and has recommended for its adoption;}

WHEREAS, after a careful review by the Committee to which the matter was referred to, it was found out that it is within the ambit of the provisions of the Local Government Code of 1991;
