RESOLVED FURTHER: That the Sangguniang Bayan of Carrascal, this Province, shall submit their Supplemental Annual Investment Program (SAIP) No. 1 CY 2026 to the Department of the Interior and Local Government, this Province pursuant to Executive Order No. 9 of the President of the Philippines dated March 9, 2001.
