AFFIRMING ORDINANCE NO. 03 DATED JANUARY 28, 2026 OF THE MUNICIPALITY OF MARIHATAG, THIS PROVINCE ENTITLED “AN ORDINANCE ESTABLISHING POLICY GUIDELINES FOR THE CONSTRUCTION, MAINTENANCE, AND PROTECTION OF SEA WALLS IN THE MUNICIPALITY OF MARIHATAG, PROVINCE OF SURIGAO DEL SUR, PRESCRIBING TECHNICAL STANDARDS, COMMUNITY PARTICIPATION MECHANISMS, IMPLEMENTATION FRAMEWORKS, AND PENALTIES FOR NON-COMPLIANCE”, IT BEING WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNIAN BAYAN CONCERNED TO ENACT SUCH ORDINANCE PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991
