AFFIRMING ORDINANCE NO. 002 DATED FEBRUARY 4, 2026 OF THE CITY OF TANDAG, THIS PROVINCE ENTITLED "INSTITUTIONALIZING SUPPORT FOR THE DEPARTMENT OF EDUCATION-ALTERNATIVE LEARNING SYSTEM (DEPED-ALS) IN THE CITY OF TANDAG, PROVIDING FUNDS THEREFOR, AND FOR OTHER PURPOSES", IT BEING WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNIAN PANLUNGSOD CONCERNED TO ENACT SUCH ORDINANCE PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991
