AFFIRMING ORDINANCE NO. 07 DATED MARCH 23, 2026 OF THE MUNICIPALITY OF BAYABAS, THIS PROVINCE ENTITLED "AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 09, SERIES OF 2025, PROVIDING 9 YEARS OF SERVICE, COMMULATIVE OR AGGREGATE, FOR ELECTED MUNICIPAL OFFICIALS OF THIS MUNICIPALITY TO BE ELIGIBLE FOR THE BENEFITS OR ENTITLEMENTS UNDER THE SAID ORDINANCE", IT BEING WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNIAN BAYAN CONCERNED TO ENACT SUCH ORDINANCE PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991

(a) No. 1 (i) of the Local Government Code of 1991 provides that, "the sangguniang panlalawigan shall review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the sanggunian and of the mayor";

WHEREAS, Ordinance No. 07 dated March 23, 2026 of the Municipality of Bayabas, this Province entitled "An Ordinance Amending Municipal Ordinance No. 09, Series of 2025, Providing 9 Years of Service, Commulative or Aggregate, for Elected Municipal Officials of this Municipality to be Eligible for the Benefits or Entitlements Under the Said Ordinance", was submitted to this Body for review and same was referred to the Committees on Social Services and Community Development, Differently Abled or Persons with Disabilities and Senior Citizens (Lead Committee)/Labor and Government Employment, for appropriate action;

WHEREAS, after a careful review by the Committees to which the matter was referred to, it was found out that it is within the ambit of the provisions of the Local Government Code of 1991;

WHEREAS, in view of the foregoing and on motion of _____ and jointly seconded by _____ and _____;

NOW THEREFORE

BE IT RESOLVED by the Sangguniang Panlalawigan of Surigao del Sur to affirm Ordinance No. 07 dated March 23, 2026 of the Municipality of Bayabas, this Province entitled "An Ordinance Amending Municipal Ordinance No. 09, Series of 2025, Providing 9 Years of Service, Commulative or Aggregate, for Elected Municipal Officials of this Municipality to be Eligible for the Benefits or Entitlements Under the Said Ordinance", it being within the scope of the prescribed powers of the Sangguniang Bayan concerned pursuant to enact such Ordinance to the Local Government Code of 1991.
