AFFIRMING ORDINANCE NO. 09 DATED MARCH 24, 2026 OF THE MUNICIPALITY OF BAYABAS, THIS PROVINCE ENTITLED "AN ORDINANCE AMENDING ORDINANCE NO. 13, SERIES OF 2022, OF THIS MUNICIPALITY, SETTING THE NEW PROVISIONAL FARE RATE MATRIX FOR TRICYCLES GRANTED WITH THE FRANCHISE TO OPERATE IN THE MUNICIPALITY, IN VIEW OF THE SKYROCKETING INCREASE IN PRICES OF PETROLEUM PRODUCTS", IT BEING WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNIAN BAYAN CONCERNED TO ENACT SUCH ORDINANCE PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991

WHEREAS, Chapter 3, Article III, Section 486, Par. (a) No. 1 (i) of the Local Government Code of 1991 provides that, "the Sangguniang Panlalawigan shall review all ordinances approved by Sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the Sanggunian and of the Mayor";

WHEREAS, Ordinance No. 09 dated March 24, 2026 of the Municipality of Bayabas, this Province entitled "An Ordinance Amending Ordinance No. 13, Series of 2022, of this Municipality, Setting the New Provisional Fare Rate Matrix for Tricycles Granted with the Franchise to Operate in the Municipality, in View of the Skyrocketing Increase in Prices of Petroleum Products", was submitted to this Body for review and same was referred to the Committees on Transportation, Traffic, Ports and Terminal (Lead Committee)/Ways and Means and Taxation, for appropriate action;

WHEREAS, after a careful review by the Committees to which the matter was referred to, it was found out that it is within the ambit of the provisions of the Local Government Code of 1991;

WHEREAS in view of the foregoing and on motion of _____ and duly seconded by _____;

NOW THEREFORE

BE IT RESOLVED by the Sangguniang Panlalawigan of Surigao del Sur to affirm Ordinance No. 09 dated March 24, 2026 of the Municipality of Bayabas, this Province entitled "An Ordinance Amending Ordinance No. 13, Series of 2022, of this Municipality, Setting the New Provisional Fare Rate Matrix for Tricycles Granted with the Franchise to Operate in the Municipality, in View of the Skyrocketing Increase in Prices of Petroleum Products", it being within the scope of the prescribed powers of the Sangguniang Bayan concerned to enact such Ordinance pursuant to the Local Government Code of 1991.
