↓ **WHEREAS**, Chapter 3, Article III, Section 486, Par. (a) No. 1 (i) of the Local Government Code of 1991 provides that, "the Sangguniang Panlalawigan shall review all ordinances approved by Sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the Sanggunian and of the Mayor";

WHEREAS, Ordinance No. 34 dated March 17, 2026 of the Municipality of Carmen, this Province entitled "An Ordinance Regulating the Preparation and Sale of Meat, Poultry, Fish, Vegetables, Fruits, Dairy Products, and Other Foodstuffs for Public Consumption in the Municipality of Carmen, Surigao del Sur, Providing Penalties for Violations Thereof, and for Other Purposes", was submitted to this Body for review and same was referred to the Committees on Trade, Industry, Investment and SMEs/ Local Economic Enterprises and Utilities (Lead Committee)/Agriculture/Fisheries, for appropriate action;

WHEREAS, after a careful review by the Committees to which the matter was referred to, it was found out that it is within the ambit of the provisions of the Local Government Code of 1991;

WHEREAS in view of the foregoing and on motion of _____ and duly seconded by _____;

NOW THEREFORE

BE IT RESOLVED by the Sangguniang Panlalawigan of Surigao del Sur to affirm Ordinance No. 34 dated March 17, 2026 of the Municipality of Carmen, this Province entitled "An Ordinance Regulating the Preparation and Sale of Meat, Poultry, Fish, Vegetables, Fruits, Dairy Products, and Other Foodstuffs for Public Consumption in the Municipality of Carmen, Surigao del Sur, Providing Penalties for Violations Thereof, and for Other Purposes", it being within the scope of the prescribed powers of the Sangguniang Bayan concerned to enact such Ordinance pursuant to the Local Government Code of 1991.
