AFFIRMING ORDINANCE NO. 42 DATED MARCH 17, 2026 OF THE MUNICIPALITY OF CARMEN, THIS PROVINCE ENTITLED "AN ORDINANCE INSTITUTING A MANDATORY PROPER QUEUING (PILA) SYSTEM IN ALL MUNICIPAL AND BARANGAY ACTIVITIES INCLUDING THE DISTRIBUTION, RELEASE AND RECEIPT OF GOODS, ASSISTANCE AND SIMILAR TRANSACTIONS WITHIN THE MUNICIPALITY OF CARMEN, SURIGAO DEL SUR AND PROVIDING PENALTIES FOR VIOLATION THEREOF", IT BEING WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNIAN BAYAN CONCERNED TO ENACT SUCH ORDINANCE PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991
