WHEREAS, Chapter 3, Article III, Section 468 Par.(a) No. 1 (i) of the Local Government Code of 1991 provides that, "the sangguniang panlalawigan shall review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the sanggunian and of the mayor";

WHEREAS, Article 59 (b)(1), Rule XII of the Implementing Rules and Regulations of the Local Government Code of 1991 provides that, "the governor shall review executive orders issued by the mayor of the component city or municipality, subject to the concurrence of the sangguniang panlalawigan, except as otherwise provided under the Constitution and special statutes";

WHEREAS, Mr. John Vincent C. Pimentel, Provincial Administrator, in his 3rd Indorsement dated March 30, 2026, for and in behalf of Hon. Manuel O. Alameda, Sr., Acting Provincial Governor, all of this Province respectfully endorsed to the 21st Sangguniang Panlalawigan thru Mr. Edgar G. Pefez, II, J.D., Secretary to the Sangguniang Panlalawigan, Executive Order No. 03 dated January 20, 2026, issued by Hon. Florencio C. Garay, City Mayor of Bislig, this Province entitled "An Order Amending Executive Order No. 55, Series of 2025 Renaming and Reconstituting the Bayfront Park Relocation and Resettlement Task Force to "Bislig City Relocation and Resettlement Task Force" (BCRRTF), Defining its composition, Functions, and for Other Purposes", for appropriate action; *after having been reviewed by ...*
