AFFIRMING ORDINANCE NO. 18 DATED MARCH 16, 2026 OF THE MUNICIPALITY OF SAN MIGUEL, THIS PROVINCE ENTITLED "AN ORDINANCE GRANTING A MONTHLY HONORARIUM OF P500.00 TO THE CHILD PROTECTION AND STRATEGIC HELPDESKS FOR INFORMATION, EDUCATION, LIVELIHOOD, AND OTHER DEVELOPMENT (SHIELD) INTERVENTION AGAINST CHILD LABOR HELP DESK OFFICERS IN EVERY BARANGAY OF THE MUNICIPALITY OF SAN MIGUEL," IT BEING WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN CONCERNED TO ENACT SUCH ORDINANCE PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991

WHEREAS, Chapter 3, Article III, Section 468 Par. (a) No. 1 (i) of the Local Government Code of 1991 provides that, "the sangguniang panlalawigan shall review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the sanggunian and of the mayor";

WHEREAS, Ordinance No. 18 dated March 16, 2026 of the Municipality of San Miguel, this Province entitled "An Ordinance Granting a Monthly Honorarium of P500.00 to the Child Protection and Strategic Helpdesks for Information, Education, Livelihood, and Other Development (Shield) Intervention Against Child Labor Help Desk Officers in Every Barangay of the Municipality of San Miguel," was submitted to this Body for review and same was referred to the Committees on Finance and Appropriation (Lead Committee)/Women, Children and Family Relations, for appropriate action;

WHEREAS, after a careful review by the Committees to which the matter was referred, it was found out that it is within the ambit of the provisions of the Local Government Code of 1991;

WHEREAS, in view of the foregoing and on motion of _____ and jointly seconded by _____ and _____;

NOW THEREFORE

BE IT RESOLVED by the Sangguniang Panlalawigan of Surigao del Sur to affirm Ordinance No. 18 dated March 16, 2026 of the Municipality of San Miguel, this Province entitled "An Ordinance Granting a Monthly Honorarium of P500.00 to the Child Protection and Strategic Helpdesks for Information, Education, Livelihood, and Other Development (Shield) Intervention Against Child Labor Help Desk Officers in Every Barangay of the Municipality of San Miguel," it being within the scope of the prescribed powers of the Sangguniang Bayan concerned pursuant to enact such Ordinance to the Local Government Code of 1991.
