AFFIRMING ORDINANCE NO. 30 DATED FEBRUARY 24, 2026 OF THE MUNICIPALITY OF CARMEN, THIS PROVINCE ENTITLED "AN ORDINANCE INSTITUTIONALIZING THE REGULAR DESILTING AND MAINTENANCE OF ALL RIVER BEDS, CREEKS, CANALS, IRRIGATION, DRAINAGE AND SIMILAR WATERWAYS WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF CARMEN, SURIGAO DEL SUR PRESCRIBING RESPONSIBILITIES, STANDARDS AND PENALTIES FOR VIOLATIONS AND FOR OTHER PURPOSES", IT BEING WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNIAN BAYAN CONCERNED TO ENACT SUCH ORDINANCE PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991

WHEREAS, Chapter 3, Article III, Section 486, Par. (a) No. 1 (i) of the Local Government Code of 1991 provides that, "the Sangguniang Panlalawigan shall review all ordinances approved by Sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the Sanggunian and of the Mayor";

WHEREAS, Ordinance No. 30 dated February 24, 2026 of the Municipality of Carmen, this Province entitled "An Ordinance Institutionalizing the Regular Desilting and Maintenance of All River Beds, Creeks, Canals, Irrigation, Drainage and Similar Waterways Within the Territorial Jurisdiction of the Municipality of Carmen, Surigao del Sur Prescribing Responsibilities, Standards and Penalties for Violations and for Other Purposes", was submitted to this Body for review and same was referred to the Committee on Education, for appropriate action;

WHEREAS, after a careful review by the Committee to which the matter was referred to, it was found out that it is within the ambit of the provisions of the Local Government Code of 1991;

BE IT RESOLVED by the Sangguniang Panlalawigan of Surigao del Sur to affirm Ordinance No. 30 dated February 24, 2026 of the Municipality of Carmen, this Province entitled "An Ordinance Institutionalizing the Regular Desilting and Maintenance of All River Beds, Creeks, Canals, Irrigation, Drainage and Similar Waterways Within the Territorial Jurisdiction of the Municipality of Carmen, Surigao del Sur Prescribing Responsibilities, Standards and Penalties for Violations and for Other Purposes", it being within the scope of the prescribed powers of the Sangguniang Bayan concerned to enact such Ordinance pursuant to the Local Government Code of 1991.
