WHEREAS, Ordinance No. 04 dated January 12, 2026 of the Municipality of Bayabas, this Province entitled "An Ordinance Amending Municipal Ordinance No. 04, Series of 2023, Entitled: Establishing SERTSS Outpost of the Municipality of Bayabas, Surigao del Sur, Activating Bantay-Bayabas 24/7, Formulating Governing Policies of its Operation and Maintenance, and Providing Funds Therefor, for it to be Responsive, Which Includes the Deployment of Personnel of SERTSS-Bayabas Chapter in the Tourism Areas of the Municipality", was submitted to this Body for review and same was referred to the Committee on Disaster Risk Reduction and Climate Change Adaptation, for appropriate action and technical review;
