WHEREAS, Chapter 3, Article III, Section 468 Par.(a) No. 1 (i) of the Local Government Code of 1991 provides that, "the sangguniang panlalawigan shall review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the sanggunian and of the mayor";

WHEREAS, likewise, Article 59 (b) (1), Rule XII of the Rules and Regulations Implementing the Local Government Code of 1991 provides that, "the governor shall review executive orders issued by the mayor of the component city or municipality, subject to the concurrence of the sangguniang panlalawigan, except as otherwise provided under the Constitution and special statutes";

WHEREAS, Hon. Johnny T. Pimentel, Provincial Governor, this Province, in his 3rd Indorsement dated March 3, 2026, respectfully endorsed to the 21st Sangguniang Panlalawigan, this Province thru Mr. Edgar G. Petez, II, J.D., Secretary to the Sangguniang Panlalawigan, Executive Order No. 2602-008 dated February 2, 2026, Executive Order Nos. 2602-009 and 2602-010 dated February 4, 2026, Executive Order Nos. 2602-011, 2602-012 and 2602-013 dated February 5, 2026 and Executive Order No. 2602-014, Series of 2026 issued by Hon. Algerico H. Irizari, Municipal Mayor, Municipality of Lanuza, this Province, for appropriate action;

WHEREAS, after a careful review of the provisions embodied in the Executive Orders, this Body found that the said Executive Orders are within the prescribed powers of the ~~City~~ Mayor concerned to issue the same pursuant to the Local Government Code of 1991 and in accordance with existing rules and regulations on the matter;
