AFFIRMING ORDINANCE NO. 03 DATED JANUARY 26, 2026 OF THE MUNICIPALITY OF CARRASCAL, THIS PROVINCE ENTITLED "AN ORDINANCE AMENDING SECTION 5 OF SANGGUNIAN BAYAN ORDINANCE NO. 04, SERIES OF 2021, ENTITLED 'AN ORDINANCE CREATING THE HUMAN RESOURCE MANAGEMENT OFFICE OF THE MUNICIPALITY OF CARRASCAL, SURIGAO DEL SUR AND APPROPRIATING FUNDS THEREFOR,' AND PROVIDING FOR THE DETAILED DUTIES AND RESPONSIBILITIES OF THE HUMAN RESOURCE MANAGEMENT OFFICE", IT BEING WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNIAN BAYAN CONCERNED TO ENACT SUCH ORDINANCE PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991

WHEREAS, Chapter 3, Article III, Section 468 Par. (a) No. 1 (i) of the Local Government Code of 1991 provides that, "the sangguniang panlalawigan shall review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the sanggunian and of the mayor";

WHEREAS, Ordinance No. 03 dated January 26, 2026 of the Municipality of Carrascal, this Province entitled "An Ordinance Amending Section 5 of Sangguniang Bayan Ordinance No. 04, Series of 2021, Entitled 'An Ordinance Creating the Human Resource Management Office of the Municipality of Carrascal, Surigao del Sur and Appropriating Funds Therefor,' and Providing for the Detailed Duties and Responsibilities of the Human Resource Management Office", was submitted to this Body for review and same was referred to the Committee on Good Government, Public Ethics and Accountability and was subsequently indorsed to the Provincial Human Resource Management Office (PHRMO) and Provincial Finance Committee (PFC), for technical review;

WHEREAS, the Provincial Finance Committee (PFC) in its letter dated May 4, 2026 informed the Body that the above-mentioned Ordinance is within the scope of the prescribed powers of the Sanggunian Bayan concerned pursuant to Sections 443 and 447 of R.A. 7160 and LBC No. 137 dated July 13, 2021 of the Department of Budget and Management, and that the said LGU has still an allowable Personal Services Cost of Php 55,335,307.20;

WHEREAS, Mr. Ace R. Orcullo, MPA, CHRA, Provincial Human Resource Management Officer, this Province in his letter dated June 26, 2026 informed the Body that the above-mentioned Ordinance is in accordance with CSC Memorandum Circular No. 12, s. 2022 and with CSC Memorandum Circular No. 06, s. 2023; returned the same with no adverse finding and has recommended for its adoption;

WHEREAS, after a careful review by the Committee to which the matter was referred to, it was found out that it is within the ambit of the provisions of the Local Government Code of 1991;

WHEREAS, in view of the foregoing and on motion of _____ and jointly seconded by _____;

NOW THEREFORE

BE IT RESOLVED by the Sangguniang Panlalawigan of Surigao del Sur to affirm Ordinance No. 03 dated January 26, 2026 of the Municipality of Carrascal, this Province entitled "An Ordinance Amending Section 5 of Sangguniang Bayan Ordinance No. 04, Series of 2021, Entitled 'An Ordinance Creating the Human Resource Management Office of the Municipality of Carrascal, Surigao del Sur and Appropriating Funds Therefor,' and Providing for the Detailed Duties and Responsibilities of the Human Resource Management Office", it being within the scope of the prescribed powers of the Sangguniang Bayan concerned to enact such Ordinance pursuant to the Local Government Code of 1991.
