

AFFIRMING RESOLUTION NO. 2026-477 DATED JUNE 2, 2026 OF THE CITY OF BISLIG, THIS PROVINCE ENTITLED "RESOLUTION APPROVING THE CITY DEVELOPMENT COUNCIL RESOLUTION NO. 5, SERIES OF 2026, ENDORSING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 7 FOR CALENDAR YEAR (CY) 2026 AMOUNTING TO ONE HUNDRED SIXTY-TWO MILLION FOUR HUNDRED ONE THOUSAND FOUR HUNDRED SIXTY-TWO PESOS AND FIFTY CENTAVOS (PHP162,401,462.50)"; IT BEING WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNIAN PANLUNGSOD CONCERNED PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991, SUBJECT TO VERIFICATION DURING THE SUBMISSION OF THE APPROPRIATION ORDINANCE TO ENSURE PLAN-BUDGET LINKAGE WHEREIN THE LOCAL BUDGETS TRULY OPERATIONALIZE APPROVED LOCAL DEVELOPMENT PLANS (SECTION 305 (i) R.A. 7160) AND ARE CONSISTENT WITH THE BUDGET OPERATIONS MANUAL (BOM) FOR LGUs 2023 EDITION

WHEREAS, Section 56 (a) of the Local Government Code of 1991 provides that, "within three (3) days after approval, the secretary to the sangguniang panlungsod or sangguniang bayan shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and the resolutions approving the local development plans and public investment programs formulated by the local development councils";

WHEREAS, Resolution No. 2026-477 dated June 2, 2026 of the City of Bislig, this Province entitled "Resolution Approving the City Development Council Resolution No. 5, Series of 2026, Endorsing the Supplemental Annual Investment Program (AIP) No. 7 for Calendar Year (CY) 2026 Amounting to One Hundred Sixty-Two Million Four Hundred One Thousand Four Hundred Sixty-Two Pesos and Fifty Centavos (PHP162,401,462.50)"; was submitted to this Body for review and same was referred to the Committees on Urban Planning and Development (Lead Committee)/Finance and Appropriation and was subsequently indorsed to the Provincial Planning and Development Office, for technical review;

WHEREAS, after the conduct of technical review, Ms. Vilma A. Ronquillo, EnP., Provincial Planning and Development Coordinator, this Province in her 2nd Endorsement dated July 2, 2026 to the August Body relative to Resolution No. 2026-477 dated June 2, 2026 of the City of Bislig, this Province, has returned the same for appropriate legislation with the information that it is in order and in conformity with the prescribed guidelines and the provisions stipulated under Department of Budget and Management - Department of Finance - Department of the Interior and Local Government - (DBM-DOF-DILG) Joint Memorandum Circular No. 01 dated November 4, 2020 guidelines;

WHEREAS, after a careful review by the Committees to which the matter was referred to, it was found out that it is within the ambit of the provisions of the Local Government Code of 1991;

WHEREAS in view of the foregoing and on motion of _____ and duly seconded by _____;

NOW THEREFORE

BE IT RESOLVED by the Sangguniang Panlalawigan of Surigao del Sur to affirm Resolution No. 2026-477 dated June 2, 2026 of the City of Bislig, this Province entitled "Resolution Approving the City Development Council Resolution No. 5, Series of 2026, 'Endorsing the Supplemental Annual Investment Program (AIP) No. 7 for Calendar Year (CY) 2026 Amounting to One Hundred Sixty-Two Million Four Hundred One Thousand Four Hundred Sixty-Two Pesos and Fifty Centavos (PHP162,401,462.50)"; it being within the scope of the prescribed powers of the Sangguniang Panlungsod concerned pursuant to the Local Government Code of 1991, subject to verification during the submission of the Appropriation Ordinance to ensure plan-budget linkage wherein the local budgets truly operationalize approved local development plans (Section 305 (i) R.A. 7160) and are consistent with the Budget Operations Manual (BOM) for LGUs 2023 Edition.

RESOLVED FURTHER: That the Sangguniang Panlungsod of the City of Bislig, this Province, shall submit their Supplemental Annual Investment Program (SAIP) No. 7 to the Department of the Interior and Local Government, this Province pursuant to Executive Order No. 9 of the President of the Philippines dated March 9, 2001.
