AFFIRMING ORDINANCE NO. 64 DATED JUNE 16, 2026 OF THE MUNICIPALITY OF CARMEN, THIS PROVINCE ENTITLED "AN ORDINANCE PROHIBITING PUBLIC UTILITY TRICYCLE FROM OPERATING WITHOUT COMPLYING WITH ALL THE NECESSARY REQUIREMENTS AS PRESCRIBED BY LAW AND MUNICIPAL ORDINANCE WITHIN THE MUNICIPALITY OF CARMEN, PROVINCE OF SURIGAO DEL SUR AND FOR OTHER PURPOSES", IT BEING WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN CONCERNED TO ENACT SUCH ORDINANCE PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991

(a) No. 1 (i) of the Local Government Code of 1991 provides that, "the Sangguniang Panlalawigan shall review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the Sanggunian and of the Mayor";

WHEREAS, Ordinance No. 64 dated June 16, 2026 of the Municipality of Carmen, this Province (Ordinance No. 64 dated June 16, 2026 of the Municipality of Carmen, this Province) entitled "An Ordinance Prohibiting Public Utility Tricycle from Operating Without Complying with All the Necessary Requirements as Prescribed By Law and Municipal Ordinance Within the Municipality of Carmen, Province of Surigao del Sur and for Other Purposes", was submitted to this Body for review and same was referred to the Committee on Transportation, Traffic, Ports and Terminal, for appropriate action;

WHEREAS, after a careful review by the Committee to which the matter was referred to, it was found out that it is within the ambit of the provisions of the Local Government Code of 1991;

BE IT RESOLVED by the Sangguniang Panlalawigan of Surigao del Sur to affirm Ordinance No. 64 dated June 16, 2026 of the Municipality of Carmen, this Province entitled "An Ordinance Prohibiting Public Utility Tricycle from Operating Without Complying with All the Necessary Requirements as Prescribed By Law and Municipal Ordinance Within the Municipality of Carmen, Province of Surigao del Sur and for Other Purposes", it being within the scope of the prescribed powers of the Sangguniang Bayan concerned to enact such Ordinance pursuant to the Local Government Code of 1991.
