HON. CAÑEDO:

Thank you very much, Honorable Presiding Officer, for recognizing. Good morning, everyone. To our Honorable Presiding Officer, Honorable Vice Governor Manuel Alameda Sr., Floor Leader, to the highly respected Members of this August Body, to our diligent Secretariat staffs, guests, and visitors, again, *maayong buntag kanato hurot*. Honorable Presiding Officer, I rise on a matter of privilege to draw the attention of this August Body to a pressing public concern affecting the safety, daily life, and basic rights of the people of our constituency that wasn't addressed by the government for decades now. Honorable Members of this Chamber, to our kind-hearted Presiding Officer, the residents of Sitio Tabuk Island, Barangay Aquino of Hinatuan, are facing serious hardships due to the absence of access of a proper footbridge or hanging bridge crossing Hinatuan, to proper population of the Municipality of Hinatuan. This is not merely an issue of infrastructure, it is an issue of human safety and dignity to our local people. Everyday, students, children, elderly citizens, PWDs, DepEd teachers, and even the daily waged workers are compromised. They are compelled to cross this dangerous stretch of the river, risking their lives, and not to mention the daily expenses that are being called from their small wages in riding the wooden boats daily. During the monsoon, or *amihan*, or even the rainy season, the situation becomes even more alarming with strong currents, frequent flooding caused by illegal mining activities from neighboring towns, and high rise of seawater level due to the effects of climate change making the passage nearly impossible for them. Several unfortunate incidents, including injuries and near-fatal accidents, especially during when they cross the said river at nighttime, have already been reported for numerous times, and also the difficulty of mobilization. During the demand of forced evacuation in times of calamity or typhoons by the Local Government Unit or the Provincial Local Government Unit. Honorable Members of this August Body, the right to safe passage and access to infrastructure to obtain education, healthcare, and livelihood is a fundamental responsibility of our government. The continued neglect of this issue .have resulted in undue suffering to the people, and repeated representations made to the concerned authorities have yielded no concrete action so far. As the guardians of public interest, this Chamber cannot remain a silent spectator while lives are put at risk and struggle on a daily basis. I therefore urge the government, through this privilege motion, to take immediate steps for further funding, action, and construction of a hanging bridge at the earliest possible time. I also request that a clear timeline be announced and the matter be treated as urgent. Keeping in view the safety and welfare of the people of Hinatuan and especially the people of Sitio Tabuk, Barangay Aquino. With these words, Honorable Presiding Officer, I place this matter before this Body and seek the kind intervention of the national government by passing a Resolution of course with the consensus of the Chairman of Public Works and Infrastructure from this Chamber, Honorable Ruel D. Momo, under the Unassigned Business/Privilege Business. So the Resolution would be a Resolution requesting Congressman Alexander T. Pimentel for the construction of hanging bridge at the proper Poblacion Hinatuan to Sitio Tabuk Island Zone 1, Barangay Aquino Hinatuan, crossing the Hinatuan River.

Honorable Presiding Officer, I'm also presenting the GPS or maybe a screenshot of the map so that you would understand the situation of the people of Sitio Tabuk Hinatuan, Surigao del Sur and I have seen the projects being made by the good Congressman from the 1st District regarding the footbridge being built from I think a barangay from the Municipality of Cortes. So I hope that in the future the good Congressman from the 2nd District would be able to take also an action in implementing this project in the said municipality.

Alameda, Sr., Vice Governor. Dear Honorable SP Members, Greetings of peace and solidarity. I am writing to respectfully request your urgent attention to a matter of significant importance. Enclosed herewith is a Memorandum of Agreement on the implementation of the Fiscal Year 2026 Risk Resiliency Program (RRP) titled "Project LAWA at BINHI or Local Adaptation to Water Access and Breaking Insufficiency through Nutritious Harvest for the Impoverished", at the Municipalities of Barobo, Bayabas, Hinatuan, Lanuza, and Lingig, all of this province. Presiding Officer, with the participant of 60 different People's Organization in the whole Province of Surigao del Sur. The rationale of that meeting is the Civil Society Organization in the Province of Surigao del Sur have a long history. With their informal organization tracing back to the early 1970s. However, their formal recognition by the Provincial Government as evidenced by the legal accreditation began in the early 90s for the record. There are 286 Civil Society Organizations accredited at the provincial level alone from 1992 to 2023, which does not include those accredited by individual, Local Government Unit (LGU). In addition, there could be around the same number of Civil Society Organizations (CSOs) that are existing but not registered. However, these accredited organizations are required to renew their accreditation periodically to remain compliant with the latest guidelines, as outlined in the Department of the Local Government Memorandum Circular 2025-060. This Circular provides updated standards and procedures for the Civil Society Organization accreditation and the creation of institutionalization of People's Council.

The formation of Local People's Councils (LPCs) in each Local Government Units (LGUs) of the Province of Surigao del Sur is progressing well, with 15 of the 19 City/Local Government Units (LGUs) having already done as of October 2025. This progress is mirrored by the province's CSOs, which are highly diverse in their size, available resources, and the scope of their missions, programs, and strategies.

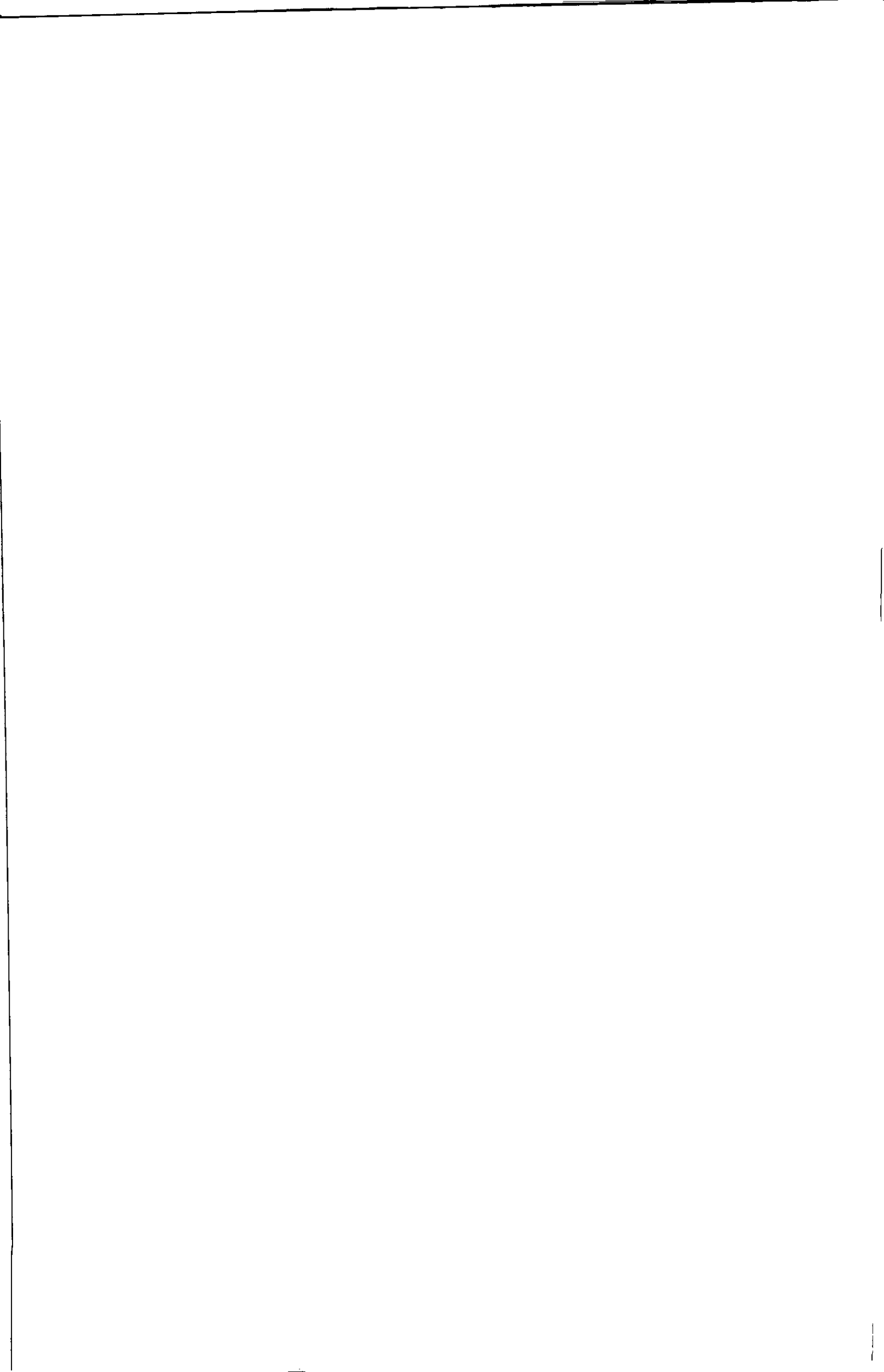

In line with the PCW-DILG-NEDA DBM JMC 2024-01, all LGUs shall ensure that all Members of the GFPS, including elected local officials and Department Heads will undergo Capacity-Building Programs on GAD, which shall include but not limited to Gender Sensitivity Training, Gender-Responsive Planning and Budgeting, Gender Analysis, Gender Audit and GAD tools such as the Gender Mainstreaming Evaluation Framework (GMEF), Gender Responsive LGU (GeRL) Assessment Tool, Harmonized Gender and Development Guidelines (HGDG), GAD Focal Point System Functionality Assessment Tool (GFAsT) for Local Government Units and other succeeding GAD tools.
