We have no visitor for **Question Hour/Visitors' Hour**.

Privilege Hour.

HON. AZARCON:

For the Privilege Hour, Honorable Presiding Officer, I don't see any names in the list. However, I know that there are a lot of insertions coming in. So it will be the norm of the Privilege Hour that we'll start with insertions. So, the first in line, who have whispered to my ear that he wants to deliver a Privilege Speech for today would be the gentleman who is an adopted Son of the 1st District, Hon. Gines Ricky J. Sayawan, Sr., because he was here since Saturday, our session would still be Monday, that is how eager he is to welcome the Honorable Provincial Governor. To be followed by another upcoming insertion gentleman will be Hon. Ruel "Wawing" Momo, unless there are others who would also whisper, that will be all as of this hour, Honorable Presiding Officer. Thank you.

HON. PRESIDING OFFICER ALAMEDA, SR.:

Now, the Honorable Board Member, Gines Ricky J. Sayawan, Sr. is recognized.

HON. SAYAWAN, SR.:

Thank you so much, Honorable Vice Governor Manuel O. Alameda, Sr., who is so refreshed now, back to his home base. Thank you also, Hon. Azarcon. Mr. Presiding Officer, we have practiced in this session about the Virtual Attendance of some Members of the Sangguniang Panlalawigan, or each of the Members of the Sangguniang Panlalawigan has been given the privilege to attend through Virtual. However, Mr. Presiding Officer, it has been observed also that during the session, and in the handling of Committee Meetings, sometimes the Chairman cannot personally handle because he is on Virtual Attendance and sometimes the hard copies, or even soft copies were not provided to them for their perusal. Thus, Mr. Presiding Officer, the attendance on virtual seems so limited, unlike if the Member of the Sangguniang Panlalawigan is physically present. We can recall, the start of Virtual Attendance, first is that during the COVID-19, Mr. Presiding Officer, Virtual Attendance was encouraged because the Department of Health itself did not permit us to be physically present in group. Second, Mr. Presiding Officer, in the rise of the fuel price, *nasakitan ta*, Mr. Presiding Officer. However, with the recent development, Mr. Presiding Officer, we seems to be used of it. The price of oil, P99, P100, or even P120 *ika nga sa kasabihan*, Mr. Presiding Officer, *masakit lang yan sa umpisa, kalaunan masanay ka na rin*. So in that sense, Mr. Presiding Officer, the rise of the price of fuel seems to be normal now from P100 and up, *di na tayo ma-shock*. So in that sense, Mr. Presiding Officer, I did not see any more valid reason unless, otherwise it will be stipulated in the Resolution later which will amend the House Rules of the Sangguniang Panlalawigan, Mr. Presiding Officer. Maybe, perhaps, if we lack of quorum and then in order to save the day to conduct Regular Session, that's the time that we will allow Virtual Attendance. If sickness will occur in one of the Members or other Members of the Sangguniang Panlalawigan and it is being approved by the majority of the Sangguniang Panlalawigan, of course, with the permission of the Vice Governor, maybe in that time, Mr. Presiding Officer, we can allow the Virtual Attendance. Thus, this humble representation, Mr. Presiding Officer, is now proposing for an amendment of the House Rules limiting the attendance in virtual session by giving only important matters. These important

matters, Mr. Presiding Officer, will be dealt with seriously during the Committee Meeting. Thus, this humble representation is proposing under Unassigned Business/Privilege Business that it will be calendared for First Reading, the amendments of the House Rules by limiting the presence in the Virtual Attendance, for First Reading, Mr. Presiding Officer, so that we can discuss this thoroughly during the Committee Meeting. Once again, thank you and good morning.

HON. PRESIDING OFFICER ALAMEDA, SR.:

Thank you also, Board Member Ricky.

Okay, our Secretary kindly take note on that.

Now, the Honorable Board Member, Engr. Wawing Momo is recognized.

HON. MOMO:

Thank you, Honorable Presiding Officer. Distinguished Members of the Sangguniang Panlalawigan, and everyone present, good morning. I rise today on a matter of concern regarding the arrest of two employees of the National Dairy Authority in connection with Magkuno Furniture, the alleged purchase from sellers located in Manyayay, Lianga. This incident has caused confusion and concern among ordinary buyers. If these furniture products are openly displayed and being sold in the community, how can an ordinary buyer determine whether buying them is prohibited by law? A person may purchase an item in good faith, believing that the seller has the legal authority to sell it, only later will be facing possible arrest or legal consequence. We fully recognize and respect the responsibility of our law enforcement and environmental authorities to protect our natural resources and enforce our laws. However, we also respectfully request the concerned agencies to clearly explain the rules governing the sale, purchase, possession and transportation of Magkuno furnitures and similar forest products. If the sale and possession of this product is prohibited or requires permit and supporting documents, the public must be properly informed. Enforcement should also look into the source of the wood, the person responsible for processing and selling it, and how such products are able to reach the market and be openly offered to unsuspecting buyers. This representation is not only interfering with the ongoing investigation nor are we declaring anyone innocent or guilty. Our primary concern is to ensure fairness, transparency, due process, and proper information for the public.

In this regard, I respectfully move that this matter and the concern raised herein be referred to the appropriate Committee for proper investigation, inquiry, and recommendation, including possible measures to protect innocent or good-faith buyers and to strengthen public awareness regarding the purchase of the regulated forest product. Let this incident serve as an opportunity for the concerned government agencies and this August Body to clarify the law, educate the public, and prevent similar incidents from happening in the future. Therefore, Honorable Presiding Officer, I propose a Resolution requesting the appropriate Committee to conduct an inquiry in aid of legislation regarding the arrest of two National Dairy Authority employees in connection with their alleged purchase of Magkuno furnitures from sellers in Manyayay, Lianga and to recommend measures to provide clear information and protection to good-faith buyers of wood products. If there's no objection, I would like to move this Resolution under First Reading, Honorable Chair.

HON. PRESIDING OFFICER ALAMEDA, SR.:

Okay, thank you for that, Board Member Wawing.

HON. AZARCON:

Just point of order. The Privilege Speech of Hon. Ruel “Wawing” Momo, would mean that the matter would be referred to the Committee on Environmental Protection and Ecology as the Lead Committee and the Supporting Committee would be the Committee on Laws and Justice and Human Rights, with an invitation to the CENRO of Lianga or any representative and from the PNP Lianga Police Station, the Chief of Police of Lianga or any representative thereof.

Now, the come backing Board Member, Honorable Presiding Officer wants to deliver an addendum to his Privilege Speech. So, may I ask that Hon. Gines Ricky J. Sayawan, Sr. be again recognized.

HON. PRESIDING OFFICER ALAMEDA, SR.:

Okay, again, Hon. Ricky, you are recognized.

HON. SAYAWAN, SR.:

Thank you so much, Hon. Azarcon, and thank you so much, of course, the good-looking Vice Governor, Hon. Manuel “Mangi” Alameda, Sr., once again, good morning. Mr. Presiding Officer, *pwede makita nato ang video*, Sir Orlan? (Showing the video)

Last August 6, 2026, Mr. Presiding Officer, the District of Maraville, Barangay Tabon, Bislig City, Surigao del Sur was hit by a fire, and then, on the following day, Mr. Presiding Officer, on August 7, 2026, again, the fire hit this time in Castillo Village, Mangagoy. The Fire Marshal, Mr. Presiding Officer, has just assumed his Office last July 2, 2026, and after barely one month, he is baptized with fire, literally, *tagbunyagan ng* fire because there are two incidents, Mr. Presiding Officer.

One incident in Maraville Village, Mr. Presiding Officer, the fire raised to 30 houses with 80 family members in total because there are house-sharer and house-renters. On August 7, Mr. Presiding Officer, there were 10 houses that were raised by fire. So, more than 80 families suffered the fire incidents, Mr. Presiding Officer.

Good thing that the Provincial Government through the PDRRMO, Mr. Presiding Officer, is so quick in their assistance. In fact, yesterday, Mr. Presiding Officer, at around 1:00 o'clock in the afternoon, the PDRRMO together with the Provincial Administrator distributed our goods to the fire victims. Then, the cash will be processed and hopefully it will be released soon and again, Mr. Presiding Officer, the Provincial Government will deliver again the services through financial assistance. However, Mr. Presiding Officer, the question does not rely so much on our assistance because what is assistance? Assistance is the after effect of the fire incident. What is most important, Mr. Presiding Officer, is how we can prevent fire. If not prevention, how can we minimize or control its damage and effect? Thus, this humble representation, Mr. Presiding Officer, would like to pass a Resolution under Unassigned Business/Privilege Business in today's session, inviting the Chief Fire Marshal of the Bureau of Fire Protection of Bislig City, Mr. Presiding Officer, in the next session in Bislig City to give an update of the fire incidents,

the causes, and the estimated damages as well as his plans and programs, how to prevent and control the fire incidents in the City of Bislig. Thank you again, Mr. Presiding Officer. Once again, good morning.

HON. PRESIDING OFFICER ALAMEDA, SR.:

Again, thank you for that, Board Member Ricky.

What's now the pleasure?

HON. AZARCON:

Yes, Honorable Presiding Officer, I don't want to end the Privilege Hour without giving the floor to Hon. Tonton Cañedo. So may I ask that he be recognized and be given the floor to deliver his Privilege Speech.

HON. PRESIDING OFFICER ALAMEDA, SR.:

Okay. The Honorable Board Member Tonton, you have the floor.

HON. CAÑEDO:

Thank you very much, to our Floor Leader for the quick insertion and also to our Presiding Officer for recognizing. Good morning, everyone, of course, finally, the comeback of our handsome Presiding Officer of the 21st Sangguniang Panlalawigan, Vice Governor Manuel "Mangi" Alameda, Sr., of course, to our distinguished colleagues in this August Body, fellow public servants, to the hardworking and diligent Members of the Secretariat, of course, to our visitors and friends, again, *maayong buntag*.

Honorable Presiding Officer, I rise in a matter of Privilege Speech to call the attention of this Honorable Body to a historic opportunity that is before us. For this reason, I respectfully urge the Provincial Economic Development and Investment Promotion Unit (PEDIPU), in coordination with the appropriate Provincial Offices, Local Government Unit, especially through the coordination of the LGU of General Luna, Siargao Island, who is the host, to take the opportunity presented by the WSL Championship Tour to establish an investment showcase for Surigao del Sur. This showcase can serve as a strategic platform where we can present the province investment opportunities to potential local and foreign investors. We should prominently feature our tourism industry, our beaches, waterfalls, rivers, caves, mountains, forests, marine resources, cultural attractions, adventure destinations, and other emerging tourism

areas. But beyond tourism, we should also present opportunities in agriculture, fisheries, agro-processing, food production, renewable energy, hospitality, transportation, logistics, infrastructure, ecotourism, and other priority sectors that can generate employment, sustainable economic growth for our people. We should not simply tell investors that Surigao del Sur is beautiful. We should tell them that Surigao del Sur is ready for investment. We should provide them with concrete information, what areas are open for investment? What projects are available? What incentives can investors access? What infrastructure is already in place? What opportunities exist for public-private partnership? What support can the Provincial Government provide? Most importantly, we should demonstrate that our province is committed to responsible, inclusive, and sustainable investment. Investment that respects our environment, empowers our communities, creates decent jobs that benefits our local entrepreneurs and people.

Honorable colleagues, the WSL Championship Tour in Siargao Island is a rare opportunity to put our province on an international stage. Thousands of visitors and stakeholders will be coming to our Region. International media will be watching. Businesses will be looking for opportunities, and investors will be searching for the next destination where they can bring their capital, expertise, and enterprises. We should not wait for them to discover Surigao del Sur by accident. We must introduce Surigao del Sur to them deliberately, professionally, and confidently. Let us prepare an investment portfolio showcasing the best that our province has to offer. Let us produce investment brief destination profiles, project presentations, promotional materials, and other that can be made available to prospective visitors. Let us bring together our municipalities and cities so that each local government can present its own unique investment and tourism opportunity. Let us make WSL Championship a gateway not only for sports tourism, but for long-term economic partnership investment and investments in Surigao del Sur. This is an opportunity to transform visibility into investment. Investment into employment, and employment into a better quality of life of our people. We have the resources, we have the destinations, we have the hardworking and talented people. What we need is a coordinated strategy to bring these opportunities to the attention of the world. Therefore, I respectfully call upon the PEDIPU or Provincial Economic Development and Investments Promotion Unit to take the lead in developing an investment showcase for our beloved Province of Surigao del Sur in connection with the historic WSL Championship Tour in Siargao Island, Surigao del Norte. Historic since that this is the only competition or championship tour that will be held in the Philippines, and I'm not sure if it is going to happen again in the next decade. Let's seize this moment, let's make sure that when the world comes to surf in Siargao, the world will also discover our Province of Surigao del Sur and when investors ask, where is the next great investment destination? Let us be ready to answer, come and visit Surigao del Sur, because this is not simply about promoting a province, this is about opening doors to opportunity for our people. This is about creating jobs, encouraging enterprises, strengthening our local economy, building a future where the natural wealth potential of Surigao del Sur translate into a meaningful and sustainable progress. Let us make this event or the WSL Championship Tour more than a historic event. Let us make it a historic economic opportunity for Surigao del Sur.
