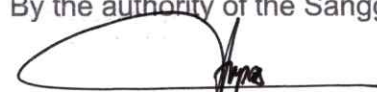

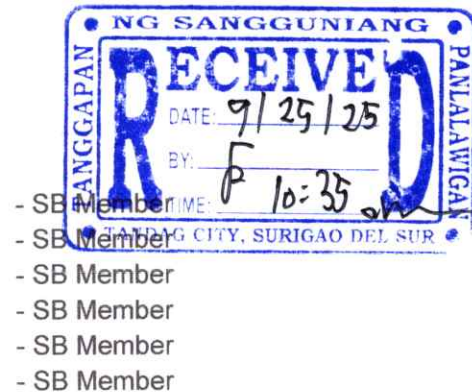

WHEREAS, Section 76 of the Republic Act No. 7160, otherwise known as the “Local Government Code
of 1991”, mandates local government units (LGUs) to undertake periodic review and adjustment of their
organizational structure and staffing pattern to promote efficiency, economy, and responsiveness in local
governance;

WHEREAS, Section 447 of the same Code empowers the Sangguniang Bayan to determine the positions and the salaries, wages, allowances, and other emoluments of officials and employees paid wholly or mainly from municipal funds;

WHEREAS, upon evaluation and assessment of the plantilla positions of the Municipality of Madrid, certain positions have been found to be long-vacant and/or no longer consistent with the current needs and priorities of the LGU;

WHEREAS, the abolition of such positions is necessary to streamline operations, enhance efficiency, and allow for the reallocation of Personal Services (PS) savings to more relevant plantilla positions that address the municipality's service delivery mandates and institutional priorities;

NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF MADRID, SURIGAO DEL SUR, IN SESSION DULY ASSEMBLED, THAT:

SECTION 1. ABOLITION OF VARIOUS POSITIONS.

The following plantilla positions in the Municipal Government of Madrid are hereby abolished:

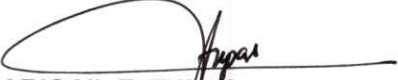

SECTION 4. EFFECTIVITY. This ordinance shall take effect immediately upon approval.

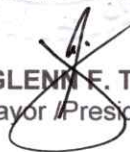
