VIII - Question/Visitors' Hour

During the Question Hour/Visitor's Hour, Hon. Henrich M. Pimentel took the floor. As per his observation during the singing of the Surigao del Sur hymn in the video presentation the background of which are were the tourist destinations of the Province of Surigao del Sur. He asked the Honorable Temporary Presiding Officer and the Chairman of the Committee on Tourism, Culture, Arts and Heritage for and in the absence of the Provincial Tourism Officer that one of the famous tourist destinations in the 1st District, which is Villa Azarcon Mountain Resort, owned and managed by the Hon. Antonio C. Azarcon was not included in the video. He said that even Hon. Romeo S. Momo, Sr., Congressman of the First District of the Province of Surigao del Sur promoted the Villa Azarcon Mountain Resort, especially that it is the first tourist destination that offers a driving range if one likes to or wants to play golf. Since, it was not included, he manifested and requested those whoever is the in-charge, the Provincial Tourism Officer, that the Villa Azarcon Mountain Resort be included in the official video presentation in promoting the tourist destinations of the Province of Surigao del Sur.

In response, Hon. Jose Dumagan, Jr. addressed the observation of Hon. H. Pimentel that in the video presentation, Villa Azarcon was not duly promoted. He then informed each and everyone that the provincial government under the Provincial Tourism Office has been preparing the third batch presenting to showcasing the Villa Azarcon Mountain Resort and other different tourist attractions for the whole province. Since, it was properly observed that the same was not part of the presentation, as the Chairman of the said Committee, he manifested to make representations with the Provincial Government that those tourist spots that has not been included for the first three presentations should be included in the next presentation.

At this juncture, Hon. H. Pimentel thanked Hon. Jose Dumagan, Jr., Chairman, Committee on Rules, Privileges and Ethics and the Chairman, Committee on Tourism, Culture, Arts and Heritage for the acknowledgement of the said manifestation and also the Honorable Temporary Presiding Officer and the Sangguniang Panlalawigan Members for their manifestations.

IX - Privilege Hour

During the Privilege Hour, Hon. Antonio C. Azarcon, Floor Leader informed the Body that the Honorable Sangguniang Panlalawigan Members who will deliver their privilege speeches in the day's session are the following, namely: Hon. Gines Ricky J. Sayawan, Sr. and Hon. Henrich M. Pimentel.

The first who took the floor was Hon. Gines Ricky J. Sayawan, Sr.. He greeted one and all a pleasant morning. He informed the Body that last September 21, 2025, there was a massive action of the people of the Philippines and they have seen how chaotic it was, especially in Metropolitan Manila during that day. According to him, there were several marches of several vineyards and it reached even up to Mindanao. He recalled that in that day it was also the anniversary on the declaration of the Martial Law of the Philippines last September 21, 1972 and the effect of that Martial Law has reached even the kids of the 80s, including himself. With that, they all feel the fear of being red-tagged as one of the activists. There were several individuals who were put in prison just because they were placed under the red-tag of the government. Again, September 21, 2025, another massive protest not for Marcos Sr., but this time for Marcos Jr.. He was afraid that this protest will still continue and the red tagging of the government will again be reborned with the present administration. He clarified that red tagging are not only for those who have protested in the streets, but those who have protected the human rights of the people. With this, he contemplated as to how are they going to protect those protector of human rights. Accordingly, during his first term as Board Member, he has been red-tagged considering his background as a supporter of the Bayan Muna. With this, he manifested to pass an Ordinance "An Ordinance Protecting the Rights and Fundamental Freedoms of Human Rights Defenders Operating in the Province of Surigao del Sur Through the Establishment of the Protective Mechanisms and Appropriating Funds for the Purpose". He then manifested that the matter be calendared for First Reading in the day's session and the Committee Meeting will be conducted the soonest possible time.

This time, Hon. Henrich M. Pimentel took the floor during the Privilege Hour. His concern was relative to the letter coming from Hon. Johnny T. Pimentel, Provincial Governor, this Province dated September 12, 2025 addressed to the Members of the Sangguniang Panlalawigan, Office of the Provincial Council, this Province thru Hon. Manuel O. Alameda, Sr., Vice Governor, requesting the Honorable Body for the passage of a Resolution authorizing the Honorable Provincial Governor to enter into and sign a Memorandum of Agreement (MOA) with the Philippine Center for Postharvest Development and Mechanization duly represented by its Director IV, Dionasio G. Alvindia, Ph.D., and the Department of Agriculture duly represented by its Regional Executive Director, Arlan M. Mangelen regarding the implementation of the Registration of Ownership of Agricultural and Fisheries Machinery and Equipment System (RAFMES). Attached to the said requests was a copy of draft MOA for perusal. Finding merit of the aforesaid request, he then manifested to pass a Resolution in Unassigned Business/Privilege Business in the day's session entitled "Authorizing Hon. Johnny T. Pimentel, Provincial Governor, this Province to Enter Into and Sign a Memorandum of Agreement (MOA), for and in Behalf of the Provincial Government of Surigao del Sur with the Philippine Center for Post Harvest Development and Mechanization Represented by its Director Dionisio G. Alvindia, PhD. and the Department of Agriculture Represented by its Regional Director Arlan M. Mangelen Regarding the Implementation of the Registration of Ownership of Agricultural and Fisheries Machinery and Equipment System (RAFMES)".

Hon. H. Pimentel's second concern was relative to the letter coming from Hon. Johnny T. Pimentel, Provincial Governor, this Province dated September 16, 2025 addressed to the Members of the Sangguniang Panlalawigan, Office of the Provincial Council, this Province thru

Hon. Manuel O. Alameda, Sr., Vice Governor, requesting the Honorable Body for the passage of a Resolution regarding the allocation to the sustainment activities in support of Local Peace Engagement and Transformation Program of the Hamugaway Peace and Development Center from Six Million Three Hundred Seventy-Seven Thousand Seven Hundred Seventy-Seven Pesos and Seventy-Eight Centavos (P6,377,777.78) to Six Million Three Hundred Seventy-Five Thousand Pesos Only (P6,375,000.00). Attached to the said request was the letter of Ms. Ann Uytico and the draft MOA for perusal. Finding the laudable intent to the said request, he manifested to pass a Resolution in Unassigned Business/Privilege Business in the day's session entitled "Authorizing Hon. Johnny T. Pimentel, Provincial Governor, this Province to Enter Into and Sign a Memorandum of Agreement (MOA), for and in Behalf of the Provincial Government of Surigao del Sur with the Office of the Presidential Adviser on Peace, Reconciliation and Unity (OPAPRU), Represented by OPAPRU Secretary Carlito G. Galvez, Jr., Regarding the Allocation of Six Million Three Hundred Seventy Five Thousand Pesos (P6,375,000.00) for the Sustainment Activities in Support of Local Peace Engagement and Transformation Program of the Hamugaway Peace and Development Center".

Hon. H. Pimentel last concern was relative to the letter coming from Hon. Johnny T. Pimentel, Provincial Governor, this Province dated September 5, 2025 addressed to the Members of the Sangguniang Panlalawigan, Office of the Provincial Council, this Province thru Hon. Manuel O. Alameda, Sr., Vice Governor, requesting to amend "Ordinance No. 71-21 Dated August 10, 2021 Entitled "Creating the Positions of Chemists IV, SG 22, Chemists III, SG 18, Medical Technologist III, SG 18, Medical Technologist I, SG 11 and Laboratory Aide II, SG 4 under the Provincial Health Office (PHO), this Province by Changing the Qualification Standards for the Positions of Chemist IV and Chemist III to Conform with CSC MC No. 11-2018". According to him, since it was an Ordinance, it requires to pass the mandatory three readings. He then manifested that the matter be referred for First Reading and be calendared for a Committee Meeting in the next Committee Meeting to be conducted in Tandag City on September 29, 2025.

Hon. H. Pimentel requested for a recess at 9:52 in the morning.

After the recess, he manifested that the matter be referred for First Reading and same be calendared for Second Reading in the next session in Tandag City.

Session resumes at 9:56 in the morning.

On the same note, Hon. Gines Ricky J. Sayawan, Sr. requested Hon. H. Pimentel that the matter will go through a Committee Meeting next week, not necessarily for Second Reading so that they can thoroughly discuss it during the Committee Meeting. He then suggested that the Committee Meeting will be on Monday to fast track the approval of the said Ordinance so that by Tuesday they can approve the matter for Second Reading and eventually on Third and Final Reading because usually the process of the Sangguniang Panlalawigan is that whenever there was a matter to be calendared for First Reading, a Committee Meeting will follow.

Hon. Jose Dumagan, Jr. agreed with the suggestion of Hon. Sayawan, Sr. that the matter will go through a Committee Meeting but the purpose was for the clarification of the request coming from the Office of the Governor and to give them ample time in considering the details and the facts and to give them ample time to study the matter. He reiterated that the final procedure is to calendar the matter for Committee Meeting on Monday.
