

AFFIRMING ORDINANCE NO. 22 DATED AUGUST 26, 2025 OF THE MUNICIPALITY OF CARMEN, THIS PROVINCE ENTITLED "AN ORDINANCE AUTHORIZING THE LOCAL GOVERNMENT UNIT OF CARMEN TO ACQUIRE, THROUGH EXPROPRIATION, CERTAIN PRIVATELY-OWNED LANDS ADJACENT TO THE HUBASON RIVER RESORT AND ADVENTURE TRAIL FOR TOURISM DEVELOPMENT, ENVIRONMENTAL PROTECTION, AND PUBLIC USE, APPROPRIATING FUNDS THEREFOR, AND FOR OTHER PURPOSES", IT BEING WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNIAN BAYAN CONCERNED TO ENACT SUCH ORDINANCE PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991

WHEREAS, Chapter 3, Article III, Section 468 Par. (a) No. 1 (i) of the Local Government Code of 1991 provides that, "the sangguniang panlalawigan shall review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the sanggunian and of the mayor";

WHEREAS, Ordinance No. 22 dated August 26, 2025 of the Municipality of Carmen, this Province entitled "An Ordinance Authorizing the Local Government Unit of Carmen to Acquire, Through Expropriation, Certain Privately-Owned Lands Adjacent to the Hubason River Resort and Adventure Trail for Tourism Development, Environmental Protection, and Public Use, Appropriating Funds Therefor, and for Other Purposes", was submitted to this Body for review and same was referred to the Committee on Laws and Justice and Human Rights (Lead Committee)/ Tourism, Culture, Arts and Heritage, for appropriate action;

WHEREAS, after a careful review by the Committees to which the matter was referred to, it was found out that it is within the ambit of the provisions of the Local Government Code of 1991;

BE IT RESOLVED by the Sangguniang Panlalawigan of Surigao del Sur to affirm Ordinance No. 22 dated August 26, 2025 of the Municipality of Carmen, this Province entitled "An Ordinance Authorizing the Local Government Unit of Carmen to Acquire, Through Expropriation, Certain Privately-Owned Lands Adjacent to the Hubason River Resort and Adventure Trail for Tourism Development, Environmental Protection, and Public Use, Appropriating Funds Therefor, and for Other Purposes", it being within the scope of the prescribed powers of the Sangguniang Bayan concerned to enact such Ordinance pursuant to the Local Government Code of 1991.
