AFFIRMING ORDINANCE NO. 14 DATED JULY 29, 2025 OF THE MUNICIPALITY OF BAROBO, THIS PROVINCE ENTITLED "ORDINANCE TRANSFERRING THE TWO UNITS OF EQUIPMENT FROM THE MOTORPOOL/HEAVY EQUIPMENT SECTION UNDER THE OFFICE OF THE MAYOR TO THE MUNICIPAL ENVIRONMENT AND NATURAL RESOURCES OFFICE (MENRO) FOR SOLID WASTE MANAGEMENT AND OPERATION, THEREBY AMENDING SECTION 5 OF MUNICIPAL ORDINANCE NO. 10, SERIES OF 2024 RE: "ORDINANCE FURTHER AMENDING MUNICIPAL ORDINANCE NO. 31, SERIES OF 2020 ENTITLED "TRANSFERRING THE OPERATION OF THE MOTORPOOL/HEAVY EQUIPMENT UNDER THE MUNICIPAL ECONOMIC ENTERPRISE OFFICE (MEEEO) TO THE OFFICE OF THE MUNICIPAL MAYOR UNDER THE ENGINEERING OFFICE", BUT IS NOW A NEW SECTION OF THE EXECUTIVE OFFICE – THE MOTORPOOL, UNDER A NEW MANAGEMENT AND SUPERVISION"", IT BEING WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN CONCERNED TO ENACT SUCH ORDINANCE PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991

WHEREAS, Chapter 3, Article III, Section 468 Par. (a) No. 1 (i) of the Local Government Code of 1991 provides that, "the sangguniang panlalawigan shall review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the sanggunian and of the mayor";

WHEREAS, Ordinance No. 14 dated July 29, 2025 of the Municipality of Barobo, this Province entitled "Ordinance Transferring the Two Units of Equipment from the Motorpool/Heavy Equipment Section Under the Office of the Mayor to the Municipal Environment and Natural Resources Office (MENRO) for Solid Waste Management and Operation, Thereby Amending Section 5 of Municipal Ordinance No. 10, Series of 2024 Re: "Ordinance Further Amending Municipal Ordinance No. 31, Series of 2020 Entitled "Transferring the Operation of the Motorpool/Heavy Equipment Under the Municipal Economic Enterprise Office (MEEEO) to the Office of the Municipal Mayor Under the Engineering Office", But is Now a New Section of the Executive Office – the Motorpool, Under a New Management and Supervision"", was submitted to this Body for review and same was referred to the Committee on Good Government, Public Ethics and Accountability, for appropriate action;

WHEREAS, after a careful review by the Committee to which the matter was referred to, it was found out that it is within the ambit of the provisions of the Local Government Code of 1991;

BE IT RESOLVED by the Sangguniang Panlalawigan of Surigao del Sur to affirm Ordinance No. 14 dated July 29, 2025 of the Municipality of Barobo, this Province entitled "Ordinance Transferring the Two Units of Equipment from the Motorpool/Heavy Equipment Section Under the Office of the Mayor to the Municipal Environment and Natural Resources Office (MENRO) for Solid Waste Management and Operation, Thereby Amending Section 5 of Municipal Ordinance No. 10, Series of 2024 Re: "Ordinance Further Amending Municipal Ordinance No. 31, Series of 2020 Entitled "Transferring the Operation of the Motorpool/Heavy Equipment Under the Municipal Economic Enterprise Office (MEEEO) to the Office of the Municipal Mayor Under the Engineering Office", But is Now a New Section of the Executive Office – the Motorpool, Under a New Management and Supervision"", it being within the scope of the prescribed powers of the Sangguniang Bayan concerned to enact such Ordinance pursuant to the Local Government Code of 1991.
