

WHEREAS, the proposed Supplemental Annual Investment Program (SAIP) No. 3 for Calendar Year 2025 is necessary for the Municipal Government of Carmen, Surigao del Sur to effectively deliver services and implement priority infrastructure projects aimed at improving the quality of life of its constituents;

WHEREAS, one of the Programs, Projects, and Activities (PPAs) under the 20% Local Development Fund (LDF) for Fiscal Year 2025, entitled "Repair of Roofing, ELCAC Livelihood Center at Sitio Tabinas", is hereby recommended for cancellation and non-implementation due to structural integrity concerns, as justified by the Office of the Municipal Engineer;

WHEREAS, the reallocation of funds from the canceled project to the “Upgrading of the Legislative Building” is deemed necessary and urgent to improve the functionality, safety, and working environment of the legislative offices, thereby enhancing local governance and public service delivery;

WHEREAS, the proposed change is consistent with the development priorities of the municipality and compliant with the allowable uses of the 20% Local Development Fund;

WHEREAS, the reprogramming of the affected PPA is hereby presented as follows:



JUSTIFICATION FOR THE CANCELLATION OF THE PROJECT: "REPAIR OF ROOFING, ELCAC LIVELIHOOD CENTER AT SITIO TABINAS" (20% LDF 2025)

The proposed project entitled "Repair of Roofing, ELCAC Livelihood Center at Sitio Tabinas," with an allocated amount of ₱500,000.00 under the 20% Local Development Fund (LDF) for FY 2025, is hereby recommended for cancellation and non-implementation due to structural integrity concerns.

Upon evaluation and site inspection, it was determined that the main structure of the building is already weak and dilapidated, primarily constructed from wood materials that have significantly deteriorated over time. The existing roof, which was previously made of anahaw, has also decayed due to prolonged exposure to natural elements and lack of maintenance, further compromising the overall stability and safety of the structure.

Repairing the roofing alone, without addressing the foundational and structural issues of the building, poses a risk to public safety and would not be a cost-effective nor sustainable investment of public funds. Any intervention limited to roofing repair will not resolve the more critical problem of the weakened base structure and may only result in further deterioration or potential hazards.

In view of the above, the allocated budget shall instead be realigned to more viable and structurally sound projects that directly contribute to the long-term development goals and safety of the community, in accordance with the provisions and priorities of the 20% LDF.


