WHEREAS, Chapter 3, Article III, Section 468 Par. (a) No. 1 (i) of the Local Government Code of 1991 provides that, "the sangguniang panlalawigan shall review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the sanggunian and of the mayor";

WHEREAS, Resolution No. 135 dated May 20, 2025 of the Municipality of Barobo, this Province entitled "Approving the CY 2026 Annual Investment Program (AIP) of the Municipal Disaster Risk Reduction and Management Office (MDRRMO) as Endorsed by the Municipal Development Council Through its MDC Resolution No. 04, S. 2025 Entitled: 'Approving, Adopting, and Endorsing to the Sanggunian the CY 2026 Annual Investment Program (AIP) for the Municipal Disaster Risk Reduction and Management Office (MDRRMO) as Endorsed by the Municipal Disaster Risk Reduction and Management Council (MDRRMC) Through its MDRRMC Resolution No. 3, Series of 2025 Entitled 'Resolution Approving and Endorsing to the Municipal Development Council (MDC) the MDRRMO Annual Investment Program (AIP) for CY 2026 Amounting to Six Hundred Fifty-Five Million, Six Hundred Fifty Thousand Pesos (Php655,650,000.00) of the Municipality of Barobo, Surigao del Sur'" was submitted to this Body for review and same was referred to the Committees on Urban Planning and Development (Lead Committee)/Finance and Appropriation, for appropriate action and was subsequently indorsed to the Provincial Planning and Development Office, technical review;

WHEREAS, after the conduct of technical review, Ms. Vilma A. Ronquillo, EnP., Provincial Planning and Development Coordinator, this Province in her 2nd Endorsement dated August 8, 2025 returned to the August Body Resolution No. 135 dated May 20, 2025 of the Municipality of Barobo, this Province, for appropriate legislation with the information that the same is in order and in conformity with the prescribed guidelines and the provisions stipulated under Department of Budget and Management – Department of Finance – Department of the Interior and Local Government (DBM-DOF-DILG) Joint Memorandum Circular No. 01 guidelines;

WHEREAS, after a careful review by the Committees to which the matter was referred to, it was found out that it is within the ambit of the provisions of the Local Government Code of 1991;

WHEREAS, in view of the foregoing and on motion of _____ and duly seconded by _____;

NOW THEREFORE

BE IT RESOLVED by the Sangguniang Panlalawigan of Surigao del Sur to affirm Resolution No. 135 dated May 20, 2025 of the Municipality of Barobo, this Province entitled “Approving the CY 2026 Annual Investment Program (AIP) of the Municipal Disaster Risk Reduction and Management Office (MDRRMO) as Endorsed by the Municipal Development Council Through its MDC Resolution No. 04, S. 2025 Entitled: ‘Approving, Adopting, and Endorsing to the Sanggunian the CY 2026 Annual Investment Program (AIP) for the Municipal Disaster Risk Reduction and Management Office (MDRRMO) as Endorsed by the Municipal Disaster Risk Reduction and Management Council (MDRRMC) Through its MDRRMC Resolution No. 3, Series of 2025 Entitled ‘Resolution Approving and Endorsing to the Municipal Development Council (MDC) the MDRRMO Annual Investment Program (AIP) for CY 2026 Amounting to Six Hundred Fifty-Five Million, Six Hundred Fifty Thousand Pesos (Php655,650,000.00) of the Municipality of Barobo, Surigao del Sur’”, it being within the scope of the prescribed powers of the sangguniang bayan concerned pursuant to the Local Government Code of 1991, subject to verification during the submission of the appropriation ordinance to ensure plan-budget linkage wherein the local budgets truly operationalize approved Local Development Plans (section 305 (i) R.A. 7160) and are consistent with the Budget Operations Manual (BOM) for LGUs 2023 Edition”.

RESOLVED FURTHER: That the Sangguniang Bayan of Barobo, this Province, shall submit their Annual Investment Program (AIP) to the Department of the Interior and Local Government, this Province pursuant to Executive Order No. 9 of the President of the Philippines dated March 9, 2001.

Bernal, Municipal Vice Mayor/Presiding Officer and to the Municipal Planning and Development Coordinator, all of the Municipality of Barobo, this Province, for their information and guidance.
