RETURNING ORDINANCE NO. 71 DATED SEPTEMBER 23, 2024 OF THE MUNICIPALITY OF SAN MIGUEL, THIS PROVINCE ENTITLED "AN ORDINANCE AMENDING ORDINANCE NO. 28, SERIES OF 2020, ENTITLED "AN ORDINANCE CREATING TWO (2) POSITION TITLES FOR THE OFFICE OF THE MUNICIPAL AGRICULTURIST, NAMELY: 1) SENIOR HOME MANAGEMENT SPECIALIST II, SG-18, AND 2) SENIOR AGRICULTURIST II, SG-18, AND APPROPRIATING FUNDS THEREFOR," BY CHANGING THE POSITION TITLE OF SENIOR HOME MANAGEMENT SPECIALIST II (SG-18) TO SENIOR HOME MANAGEMENT SPECIALIST (SG-18) AND SENIOR AGRICULTURIST II (SG-18) TO SENIOR AGRICULTURIST (SG-18)", FOR RECTIFICATION

WHEREAS, Chapter 3, Article III, Section 468 Par. (a) No. 1 (i) of the Local Government Code of 1991 provides that, "the sangguniang panlalawigan shall review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the sanggunian and of the mayor";

WHEREAS, Ordinance No. 71 dated September 23, 2024 of the Municipality of San Miguel, this Province entitled "An Ordinance Amending Ordinance No. 28, Series of 2020, Entitled "An Ordinance Creating Two (2) Position Titles for the Office of the Municipal Agriculturist, Namely: 1) Senior Home Management Specialist II, SG-18, and 2) Senior Agriculturist II, SG-18, and Appropriating Funds Therefor," by Changing the Position Title of Senior Home Management Specialist II (SG-18) to Senior Home Management Specialist (SG-18) and Senior Agriculturist II (SG-18) to Senior Agriculturist (SG-18)", was submitted to this Body for review and same was referred to the Committee on Good Government, Public Ethics and Accountability, for appropriate action and was indorsed to the Provincial Human Resource Management Office, for technical review;

WHEREAS, Mr. Ace R. Orcullo, MPA, CHRA, Provincial Human Resource Management Officer, this Province in his letter dated August 1, 2025 upon perusal of the subject Ordinance, informed the August Body of the following observations, viz:
