DECLARING ORDINANCE NO. 04 DATED JUNE 9, 2025 OF THE MUNICIPALITY OF MADRID, THIS PROVINCE ENTITLED “AN ORDINANCE ABOLISHING THE FOLLOWING PLANTILLA POSITIONS IN VARIOUS DEPARTMENTS/OFFICES OF THE MUNICIPAL GOVERNMENT OF MADRID, SURIGAO DEL SUR TO WIT:

INVALID, CONSIDERING THAT THERE IS AN INCUMBENT FOR THE AGRICULTURAL TECHNOLOGIST POSITION UNDER THE AGRICULTURE’S OFFICE AND POSITIONS CAN ONLY BE ABOLISHED ONCE THEY BECOME VACANT

WHEREAS, Chapter 3, Article III, Section 468 Par. (a) No. 1 (i) of the Local Government Code of 1991 provides that, “the sangguniang panlalawigan shall review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the sanggunian and of the mayor”;

WHEREAS, Ordinance No. 04 dated June 9, 2025 of the Municipality of Madrid, this Province, was submitted to this Body for review and same was referred to the Committee on Good Government, Public Ethics and Accountability, for appropriate action and was indorsed to the Provincial Human Resource Management Office and to the Provincial Finance Committee (PFC), all of this Province, for technical review;

WHEREAS, Mr. Ace R. Orcullo, MPA, CHRA, Provincial Human Resource Management Officer, this Province in his letter dated July 29, 2025 upon perusal of the subject Ordinance, found the dissolution of the positions Electrician I, Mechanic III, AT – Fishery, AT – Rice and Veterinaria in different departments of the LGU of Madrid to be within the ambit of the powers granted to LGU under 7160, otherwise known as the Local Government Code of 1991. This, however, requires that no incumbent has been appointed to the post at the time of the abolition of the aforementioned positions;

WHEREAS, the Provincial Finance Committee (PFC) in its letter dated July 29, 2025 informed the Body that the above-mentioned Ordinance as per review of their current file, the two (2) Agricultural Technologist positions (Plantillas 5 and 7) are currently occupied by Ms. Carla Jean A. Fuentes and Ms. Rosalinda A. Toroy, respectively. Since positions with incumbents can only be abolished once they become vacant, the PFC recommended that the said LGU shall review the status of these positions before proceeding with the Ordinance which ensure compliance with relevant regulations and protect the rights of the incumbent personnel;

WHEREAS, after a careful deliberation on the matter, the Committee recommended to declare the aforementioned Ordinance No. 04 dated June 9, 2025 of the Sangguniang Bayan of Madrid, this Province, invalid considering that there is an incumbent for the Agricultural Technologist Position under the Agriculture’s Office in the said municipality;

WHEREAS, in view of the foregoing and on motion of _____ and duly seconded by _____;

NOW THEREFORE

BE IT RESOLVED by the Sangguniang Panlalawigan of Surigao del Sur to declare Ordinance No. 04 dated June 9, 2025 of the Municipality of Madrid, this Province entitled “An Ordinance Abolishing the Following Plantilla Positions in Various Departments/Offices of the Municipal Government of Madrid, Surigao del Sur to Wit:
