

AFFIRMING ORDINANCE NO. 14 DATED JUNE 02, 2025 OF THE MUNICIPALITY OF SAN MIGUEL, THIS PROVINCE ENTITLED "AN ORDINANCE CREATING THE POSITION TITLE OF ADMINISTRATIVE AIDE IV (BOOKBINDER II), SG-4 UNDER THE OFFICE OF THE MUNICIPAL HUMAN RESOURCE MANAGEMENT OFFICER AND TO APPROPRIATE FUNDS FOR PERSONNEL SERVICES (PS)", IT BEING WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNANG BAYAN CONCERNED TO ENACT SUCH ORDINANCE PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991

WHEREAS, Chapter 3, Article III, Section 468 Par. (a) No. 1 (i) of the Local Government Code of 1991 provides that, "the sangguniang panlalawigan shall review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the sanggunian and of the mayor";

WHEREAS, Ordinance No. 14 dated June 02, 2025 of the Municipality of San Miguel, this Province entitled "An Ordinance Creating the Position Title of Administrative Aide IV (Bookbinder II), SG-4 Under the Office of the Municipal Human Resource Management Officer and to Appropriate Funds for Personnel Services (PS)", was submitted to this Body for review and same was referred to the Committee on Good Government, Public Ethics and Accountability, for appropriate action and was indorsed to the Provincial Human Resource Management Office (PHRMO) and to the Provincial Finance Committee (PFC), all of this Province, for technical review;

WHEREAS, the Provincial Finance Committee (PFC), in its letter dated July 31, 2025, informed this August Body that the aforementioned Ordinance falls within the scope of the prescribed powers of the Sangguniang Bayan, as outlined in Section 447 of Republic Act No. 7160. Additionally, it adheres to the Local Budget Circular (LBC) No. 137, dated July 13, 2021 which provides the "Index of Occupational Services, Position Titles and Salary Grades in the Local Government Unit (IOS-LGU)", CY 2021 Edition, issued by the Department of Budget and Management.;

WHEREAS, after a careful review by the Committee to which the matter was referred to, it was found out that it is within the ambit of the provisions of the Local Government Code of 1991;
