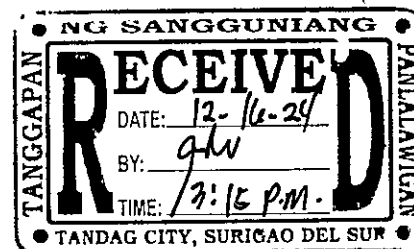

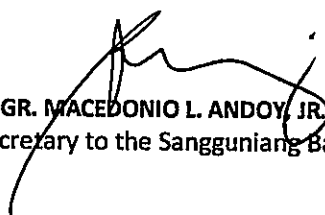

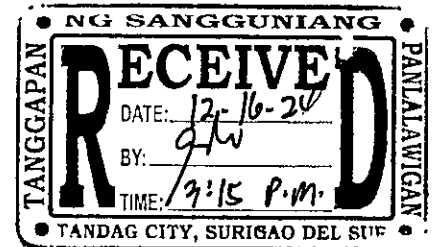

WHEREAS, this Sanggunian, thru its Senior Member – Hon. Edgardo J. Butad, has filed an administrative complaint against one of its members, Hon. Merald Poll B. Hinampas, Jr., docketed as Admin Case No. 07-2024 for: Malversation, Dishonesty, Grave Misconduct, Conduct Prejudicial to the Service, and Neglect in the Performance of Duty;

WHEREAS, as of to date, the status of the said complaint is still under deliberation by the Sangguniang Panlalawigan (SP) based on the position papers being submitted by both parties as required for its final resolution;

WHEREAS, the election ban will take effect on January 12, 2025 where suspension of elective provincial, city, municipal, or barangay officer without prior approval of the Commission is among the

prohibited acts, such that if the case mentioned above will not be resolved prior to the election ban, this will render the complaint in futility;

WHEREAS, it is the prayer of this Sanggunian with the SP that a corresponding suspension of Hon. Hinampas, as regard his infractions, be given due course in observance to Chapter 4 of the LGC of 1991 to give a warning of sort to all elective officials of this Municipality, that if there are infractions there have to be its corresponding repercussions;

WHEREAS, in view of the foregoing and on motion of Hon. Edgardo J. Butad, duly seconded by all Sangguniang Bayan Members present;

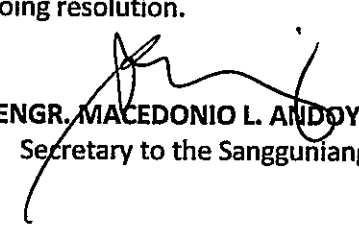
NOW THEREFORE:

BE IT RESOLVED by the Members of the Sangguniang Bayan in session assembled to earnestly request the Sangguniang Panlalawigan of Surigao del Sur to expedite the resolution of the administrative case filed with it by this Sanggunian against its member, Hon. Merald Poll B. Hinampas, Jr., in view of the election ban for 2025 mid-term elections, which will take effect on January 12, 2025.

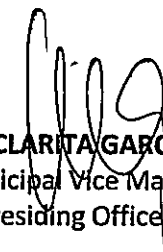
