Dear Sir,

This is to complain against Mayor Paulo Lopez in Madrid, Surigao Del Sur for installing a "lapida" tombstone in the entrance of our barangay road, from the national highway going to our barangay. In the same lapida, his name together with Vice Mayor, a Sanguniang Bayan members and lead in officers in the Municipal Hall are all indicated in the same lapida, claiming that person named in the lapida are all responsible for the concreting of the 500 meters barangay road, a portion of the 2kms. Road, the barangay road from the National highway.

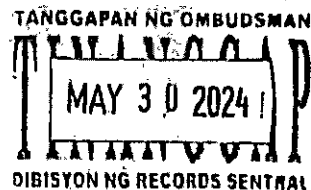
Our barangay Panayogon, Madrid, Surigao Del Sur is the only barangay in the entire Madrid, Surigao Del Sur, whose barangay road remained unpaved except for the 500 meters from the National Highway where the lapida is installed.

Because of the presence of the lapida, our barangay looks like an entrance in a cemetery as viewed from the National Highway.

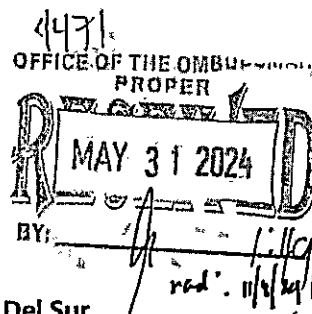
