AFFIRMING ORDINANCE NO. 2024-20 DATED MARCH 12, 2024 OF THE MUNICIPALITY OF LINGIG, THIS PROVINCE ENTITLED "THE HEALTH AND SANITATION CODE OF THE MUNICIPALITY OF LINGIG, SURIGAO DEL SUR", IT BEING WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN CONCERNED TO ENACT SUCH ORDINANCE PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991
