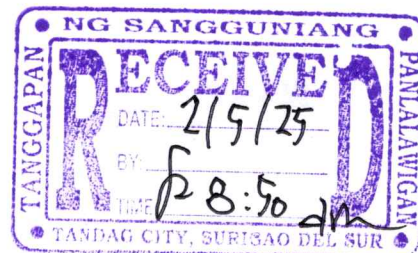

SP Ordinance No. 2025-01 "An Ordinance confirming, amending and ratifying the approved loan of the City Government of Bislig, Surigao del Sur with the Development Bank of the Philippines (DBP) for the construction of Phase 2 of the Legislative Building amounting to One Hundred Forty Million Pesos (Php140,000,000.00) and Completion of 911 Facility/Building amounting to Sixty Million Pesos (Php60,000,000.00), a total of Two Hundred Million Pesos (Php200,000,000.00)"

SECTION 1. The loan application of the City Government was duly approved by Development Bank of the Philippines (DBP) thereby requiring the City Government thru the Sangguniang Panlungsod to execute an ordinance confirming, amending, and ratifying the approved terms and conditions of the approved loan.

SECTION 2. The Sangguniang Panlungsod of Bislig City, Surigao del Sur, thru its incumbent City Mayor, Honorable Florencio C. Garay, or his successors, be, as he is authorized and empowered, for and in behalf of the City Government of Bislig;

1. To enter into loan contract for the following:

1.1 Construction of Phase 2 of the Legislative Building amounting to **ONE HUNDRED FORTY MILLION PESOS (PHP140,000,000.00)**;

1.2 Completion of 911 Facility/Building amounting to **SIXTY MILLION PESOS (PHP60,000,000.00)**, a total of **TWO HUNDRED MILLION PESOS (PHP200,000,000.00)**;

2. To sign, execute, receive, endorse and deliver any and all Promissory Notes, Deed of Assignments, Loan Agreements and any other documents which may be necessary or required to the implementation of the loan facility approved by the Development Bank of the Philippines (DBP);

3. As security of the LOAN;

3.1 To assign its 20% Internal Revenue Allotment (IRA) in favor of DBP;

SECTION 3. As acknowledgement of its loan with DBP. The foregoing loan transactions obtained from DBP shall be entered by the City Treasurer and Accountant in its books as proof of its contractual obligations with DBP;

SECTION 4. Pursuant to the provisions of Section 2 and 3 of Republic Act No. 1405 and other laws relating to the secrecy of bank deposits, the City Government of Bislig is waiving its rights to confidentiality of information by authorizing Development Bank of the Philippines with which we have transactions to disclose to the Bangko Sentral ng Pilipinas (BSP) with all information pertaining to the deposits, investments, loans or other transactions including the history of our dealings with said banks and for the BSP to make all inquiries as may be necessary regarding the same. Development Bank of the Philippines (DBP) is likewise authorized to disclose and share any such information furnished from said banks to the Department of Finance in relation to the performance by said Department of its functions;

SECTION 5. The City Government of Bislig hereby undertakes to designate DBP as its authorized IRA depository and shall be its depository bank which designation shall not be revoked or changed for as long as any portion of the LOAN herein authorized, including interests and other charges due thereon, remain outstanding;

SECTION 6. The City Government of Bislig thru its technical working committee has the sole authority and responsibility to set, determine the total cost of the said projects, and that Development Bank of the Philippines and all its personnel involved in the implementation thereon, are free from all administrative and criminal liabilities in case of observations or findings that may arise from any concerned agencies;

SECTION 7. The City Government of Bislig hereby authorize Development Bank of the Philippines to debit the LGU's deposit accounts with any DBP branches to cover payment of loan (principal, interest) and other obligations or charges with the DBP;
