**WHEREAS**, Ordinance No. 28 dated October 21, 2024 of the Municipality of Carrascal, this Province entitled “An Ordinance Creating the Position of Process Server, Salary Grade 5 Under the Office of the Municipal Mayor of this Municipality and Appropriating Corresponding Funds Therefor”, was submitted to this Body for review and was referred to the Committee on Good Government, Public Ethics and Accountability and same was endorsed to the Provincial Human Resource Management Officer and the Provincial Finance Committee for their comment and recommendation;
