WHEREAS, Section 21 (c) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that “Any national or local road, alley, park, or square may be temporary closed during an actual emergency, or fiesta celebrations, public rallies, agricultural or industrial fairs...” in the interest of public welfare;

WHEREAS, the Municipality of Madrid will celebrate Pasidungog Festival from September 8-20, 2025, highlighting various cultural, social, and economic activities that necessitate designated spaces within the Poblacion area;

WHEREAS, the Pasidungog Festival, held annually every September in honor of the 2nd Patronal Fiesta Celebration, highlights and commemorates the rich customs and traditions of the Municipality of Madrid, serving as a vital expression of its cultural heritage;

WHEREAS, the Pasidungog Festival also represents the municipality in cultural events across the Caraga Region, promoting local identity, pride, and tourism;

WHEREAS, there is a need to temporarily close certain roads to ensure the safe and orderly movement of participants and visitors, to allocate spaces for the StrEAT Market, food stalls, Ukay-ukay, and other festival activities, and to promote local commerce while fostering cultural appreciation.

NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF MADRID, SURIGAO DEL SUR, IN SESSION DULY ASSEMBLED, THAT:

SECTION 1. TEMPORARY ROAD CLOSURE. The following roads within the Poblacion of Madrid, Surigao del Sur, shall be temporarily closed during the Pasidungog 2025 celebration on the dates and times specified below:

- A. Capt. Buniel Street - for the Madrid StrEAT Market, from 4:00 PM to 12:00 midnight
- B. Urbiztondo Street - for Shakes, Snacks, and Street Foods, from 5:00 PM to 12:00 midnight
- C. San Isidro Street and Frias Street - for Ukay-ukay and Other Goods, from 5:00 PM to 12:00 midnight


SECTION 2. SEPARABILITY CLAUSE. If any provision of this Ordinance found to be inconsistent with any law, other provisions or part/s thereof not so affected shall remain in full force and effect.

SECTION 3. REPEALING CLAUSE. All Ordinances, Rules and Regulations or parts thereof, in conflict with, or contrary to, the Provisions of this Ordinance not so affected herewith is hereby repealed or modified accordingly.

SECTION 4. EFFECTIVITY. This ordinance shall take effect immediately upon approval.
