AFFIRMING RESOLUTION NO. 2025-⁴279 DATED AUGUST 19, 2025 OF THE CITY OF BISLIG, THIS PROVINCE ENTITLED "RESOLUTION APPROVING CDC EXECOM RESOLUTION NO. 8, SERIES OF 2025, ENTITLED 'ENDORISING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 6 FOR CY 2025 OF THE CITY OF BISLIG AMOUNTING TO TWENTY-ONE MILLION FOUR HUNDRED SEVENTY-FIVE THOUSAND THREE HUNDRED SIXTY-FIVE PESOS AND 35/100 (P21,475,365.35)' TO THE SANGGUNIANG PANLUNGSOD FOR APPROVAL"; IT BEING WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNIANG PANLUNGSOD CONCERNED PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991, SUBJECT TO VERIFICATION DURING THE SUBMISSION OF THE APPROPRIATION ORDINANCE TO ENSURE PLAN-BUDGET LINKAGE WHEREIN THE LOCAL BUDGETS TRULY OPERATIONALIZE APPROVED LOCAL DEVELOPMENT PLANS (SECTION 305 (i) R.A. 7160) AND ARE CONSISTENT WITH THE BUDGET OPERATIONS MANUAL (BOM) FOR LGUs 2023 EDITION
