To invoke God's presence, Hon. Jose Dumagan, Jr. led the Prayer.

IV - Roll Call

The Secretary to the Sangguniang Panlalawigan called the roll to determine the presence of quorum. Fourteen (14) Sangguniang Panlalawigan Members responded to the call including the Honorable Presiding Officer. Thus, Hon. Manuel O. Alameda, Sr., Presiding Officer declared the session in quorum.

V - Approval and Adoption of the Order of Business

After a thorough review of the Order of Business page by page and there having no corrections, comments and objections raised by the Body, said Order of Business was approved and adopted on motion of Hon. Jose Dumagan, Jr. and unanimously seconded by all Sangguniang Panlalawigan Members present. It was assigned as Resolution No. 2872-25.

At this juncture, Hon. Gines Ricky J. Sayawan, Sr. took the floor and introduced to the Body the newly appointed PESO Manager in the Province of Surigao del Sur in the person of Ms. Ana Victoria G. Millan. He then requested the Honorable Presiding Officer to recognize Ms. Millan and be given the floor.

At this juncture, Ms. Millan took the floor and greeted one and all a pleasant morning. She introduced herself as Ms. Ana Victoria G. Millan from Telaje, Tandag City who graduated with a degree of Bachelor of Science in Public Administration in Mindanao State University and was connected in the Provincial Government of Surigao del Sur for 24 years in the Provincial Human Resource Management Office. She informed the Body that last 2022 she was promoted as the Division Chief of the Human Resource Recruitment and Placement Division and on February 19, 2025, she was appointed as the Provincial Government Department Head (Public Employment Service Office Manager). She then extended her sincerest gratitude to the Honorable Governor Alexander T. Pimentel, Vice Governor Manuel O. Alameda, Sr. and to the Sangguniang Panlalawigan Members who have played a vital role to make the Provincial PESO institutionalized in the province. According to her, it is a call for her to take a greater responsibilities and that she is fully committed of embracing the role and challenges ahead. Her goal is to lead with purpose, inspire those around her, and contribute to a culture of excellence, especially in the employment services of the province.

This time, Hon. Jose Dumagan, Jr. took the floor and commented that though he did not personally knew Ms. Millan but he heard good stories coming from her fellow Officemates and he can vouch that the latter is a hard worker and a very gracious Superior Officer in their Office. According to him, the appointment extended to her by the Honorable Governor was a matter of personal preference and they all know that when it comes to appointments, the Honorable Governor will always make sure that the appointee possesses all the qualifications that was needed to run the Office. With this, he had a confidence to the appointee that she can perform the functions and responsibilities called for by the PESO Office.

On the same note, Hon. Gines Ricky J. Sayawan, Sr. relayed that the creation of PESO seems to be controversial because at first, some of the Members of the Sangguniang Panlalawigan opposed for the creation of the PESO as a Department because usually a PESO Office is always attached to the other Department, such as the Cooperative and usually the COOP Officer will act as the PESO Manager. However, the Province of Surigao del Sur was convinced that the PESO Office should be created as a Department, hence, it was institutionalized. He recalled that during the deliberation on the creation of the Office, questions were raised as to how could the Office affect the employment of the Province of Surigao del Sur and what will be the primary target of creating a PESO Office that will lead for the progress and development of the province.

In answer to the query raised by Hon. Sayawan, Sr., Ms. Millan responded that creating a PESO Office can provide reliable and sustainable employment facilitation, like the referral and the Office can also offer Job Fair, Bazaars and Livelihood for the Displaced Workers and OFWs if the programs of the Office will be funded.

Hon. Sayawan, Sr. shared his thoughts that the most important role of the Public Employment Service Office is to have a partnership with other agencies like the Technical Education and Skills Development Authority (TESDA) and Department of Labor and Employment (DOLE) and that the PESO Office will formulate an Annual Plan because at the end of the year they will be submitting the Budget and the accomplishment of the Office for the year. He then manifested that since it is a newly created Office, they are expecting an output of

the Office considering that the Provincial Government spend Millions of Pesos for the creation of that particular Office.

This time, Hon. Amado M. Layno, Jr. commented that he is not opposing for the creation of the Department. He then asked Ms. Millan as to the Vision of the PESO Office for Surigao del Sur. Ms. Millan replied that the Vision of the PESO Office was to provide a reliable and sustainable employment facilitation services to the people of Surigao del Sur that will contribute to poverty alleviation and economic development in commitment and accordance with the people's agenda.

Hon. Layno, Jr. opined that the employment should not only target the Government Departments, but also the Private Sector. He shared his observation that in Butuan City, the PESO Office will look at the Private Companies, Businesses, to the Websites and identify the needs of those companies in terms of employment so that they can provide some employment. He then suggested that the PESO will create a Website where they can offer the talents that they have in Surigao del Sur and will not just focus on the government side in terms of employment, but also browse through the needs of the Private Sector.

At this point in time, Hon. Antonio C. Azarcon took the floor and congratulated Ms. Millan for having been appointed as the Department Head of PESO. He inquired if there will be no conflict between their Office and the respective PESO Departments in every city/municipality. Ms. Millan replied that there will be no conflict because the City/Municipality will conduct their Job Fairs during Fiesta and the Province will usually have a Job Fair during the celebration of the Araw ng Surigao del Sur.

Hon. Azarcon suggested that they will coordinate with all the Local PESO so that they will have one concerted effort in trying to assist and help the constituents and be able to address coordinating activities for all of the PESO as she will be sitting as the PESO Head of the Province.

Ms. Millan responded to Hon. Azarcon that they have coordination with all the Local Government Units because they created an Association and the PESO Map of the Province. She informed the Body that they have a monthly meeting and she coordinated with all the LGUs with their monthly accomplishments.

On the same note, the Honorable Presiding Officer inquired from Ms. Millan as to what Office or training institution that could conduct a seminar or training in order to enhance, capacitate among PESO Managers in the Province, Cities and Municipalities as well as to avoid the overlapping of its functions. Ms. Millan responded that they were assisted by the Department of Labor and Employment (DOLE) in all their programs and the Technical Education and Skills Development Authority for the coaching.

In connection with the matter at hand, Hon. Jimmy I. Guinsod emphasized that one of the functions of the PESO Office is to coordinate with the Overseas Workers Welfare Administration for the programs of the Overseas Filipino Workers. He then suggested to Ms. Millan that the illegal recruiter will be arrested because some of his relatives in the Tribal Communities have been recruited by the illegal recruiters for abroad.

Lastly, Hon. John Paul C. Pimentel inquired to Ms. Millan if they have a plan of hiring a Labor Lawyer for the Office because there is a need for a specific Lawyer on employees and labor movements. Ms. Millan responded that there was already a plan of hiring a Lawyer in their Office.

After hearing various comments and suggestions, the Body agreed that they will confirm the appointment of Ms. Millan as the PESO Manager of the province.

IX - Privilege Hour

During the Privilege Hour, Hon. Antonio C. Azarcon, Floor Leader of the 20th Sangguniang Panlalawigan informed the Body that the Honorable Sangguniang Panlalawigan Members who will deliver their privilege speeches in the day's session are the following, namely: Hon. Margarita G. Garay, Hon. Jose Dumagan, Jr., Hon. Ruel D. Momo, Hon. Gines Ricky J. Sayawan, Sr., Hon. Anthony Joseph P. Cañedo, Hon. Conrad C. Cejoco and himself.

The first who took the floor was Hon. Margarita G. Garay. She greeted one and all a pleasant day. Her concern was relative to the upcoming Women's Month Celebration. She informed the Body that year 2025, in accordance with the Philippine Commission on Women, Memorandum Circular 2025-01, affirmed the dedication to advancing the rights and welfare of women in the society and marks a significant milestone in the pursuit of gender equality and women's empowerment in the Philippines and globally. Accordingly, the year 2025, commemorates the 50th anniversary of the Philippine Commission on Women (PCW), the 30th anniversary of the Beijing Platform for Action and the 45th year of the Philippines' signing of the Convention on the Elimination of All Forms of Discrimination Against Women (CEDAW). The year 2025 National Women's Month Celebration (NWMC) carries the sub-theme, "Babae sa Lahat ng Sektor, Aangat ang Bukas sa Bagong Pilipinas". It reinforces the core objective of Republic Act 9710, or the Magna Carta of Women, to empower women, promote gender equality, and ensure equitable access to resources and opportunities. It calls for a multi-Sectorial approach, engaging National Government Agencies (NGAs), Local Government Units (LGUs), Non-Government Organizations (NGOs), Civil Service Organizations (CSOs), and other strengthened legal frameworks; improve access to essential services and create sustainable opportunities for women. She relayed to the Body that the National Women's Month Celebration has suggested series of activities such as the National Women's Month Celebration-themed Flag Raising Ceremony – the Lupang Hinirang All Women Cast which encourages the NGAs and LGUs to integrate the National Women's Month Celebration announcements, reminders, messages during their Flag Raising Ceremonies during last week of February and the First Week of March (or on other relevant dates). It is strongly recommended that the All Women cast Lupang Hinirang music video be featured in the National Women's Month Celebration events during the Month of March, namely: God Forum or God Agenda Setting; Hashtag God to Know; Our Women's Month Stories or the Hashtag PCW50 HerStory and the 2025 National Women's Month Celebration banner of support; Hashtag Purple Wednesdays, or Purple Your Icon or Hashtag Purple Your Profile; Musika ng Kababaihan Fridays (#MNKFriday); Offer your own "Serbisyo para kay Juana"; Organize activities in support of the Girl Child Week and the Women with Disabilities Day celebration - wherein everyone is encouraged to join the Girl Child Week, observed during the fourth week of March. The celebration will be led by the Council for the Welfare of Children (CWC), as well as the Women with Disabilities Day celebrations headed by the National Council on Disability Affairs. All support the PCW's online advocacy and many more activities. She added, that the theme for the year 2025 celebration as outlined by the PCW emphasized the importance of inclusivity and presentation. It calls upon to ensure that every woman's voice is heard and every women's rights are protected. This is not just a task for women, but a collective responsibility for all. Along this line, she manifested to pass a Resolution in Unassigned Business/Privilege Business in the day's session entitled "Earnestly Requesting the Provincial Social Welfare and Development Office (PSWDO) to Make Recommendations in Celebration of the Women's Month 2025 as Per Philippine Commission on Women (PCW) Memorandum Circular No. 2025-01".

The next who took the floor was Hon. Jose Dumagan, Jr.. He prompted that supposedly the day's session will be held in the 2nd District at the Capitol of the South, Kahayag, Bislig City as per House Rules. However, because of some other important matters that the Members of the Sangguniang Panlalawigan will have to attend to, the Members agreed among themselves with the permission of the Honorable Vice Governor that instead of having a session in Barangay Kahayag, Bislig City, it was transferred in Tandag City. For the record, he manifested that the Members agreed to change the venue of the 129th Regular Session from Barangay Kahayag, Bislig City to the Legislative Building, Session Hall, Capitol Hills, Tandag City, this province.

At this juncture, Hon. Ruel D. Momo took the floor and informed the Body on the status of Barangay Road Construction in Barangay Pocto, Hinatuan and Barangay Pamanlinan, Bislig City, Surigao del Sur. He informed the Body that he has a record of the Status Work Accomplished (SWA) from the concreting of Pamanlinan Road Section. According to him, the State Contractors have already collected the money in the amount of P42,491,500.00 or 84% and the contract of the project is worth P49,990,000 and the remaining balance was P7,490,500.00. Another project was the concreting of Dugmanon-Pocto Road amounting to P59,990,000.00 and the Contractors have already collected 82% of the total amount of the said project worth P57,391,800.00 with the balance of P1,599,000.00. Along this line, he manifested to pass the following Resolutions in Unassigned Business/Privilege Business in the day's session, viz:

1. Resolution entitled "Earnestly Requesting the Provincial Engineering Office (PEO) to Suspend the Payment for the Final Billing of Retention Money on the Project of Concreting of Dugmanon-Pocto Road Until Such Time that Said Project Will be Rectified or Corrected"; and
2. Resolution entitled "Earnestly Requesting the Barangay Officials of Barangay Pamanlinan, Bislig City and Barangays Dugmanon and Pocto, Hinatuan, this Province to Monitor the Concreting of Pamanlinan Road Section and Dugmanon-Pocto Road Projects if it Has Already Been Rectified/Corrected".

This time, Hon. Gines Ricky J. Sayawan, Sr. took the floor during the Privilege Hour. His concern was relative to the letter-request coming from the Hon. Alexander T. Pimentel, Provincial Governor, this Province dated February 20, 2025 addressed to Hon. Manuel O. Alameda, Sr., Vice Governor thru the Honorable Members of the Sangguniang Panlalawigan, requesting for the urgent passage of an Appropriation Ordinance authorizing the utilization of Supplemental Budget No. 1 CY – 2025 amounting to Seventy Eight Million Six Thousand Five Hundred One Pesos and 13/100 (P78,006,509.13) with the attached supporting documents for the Supplemental Budget, viz:

1. Statement of Funding Sources - LBP Form No. 8 and Certification of Provincial Treasure and Provincial Accountant as to Availability of funds; and
2. Statement of Supplemental Appropriations –LBP Form No. 9. It was noted that the PPAs under the Supplemental Appropriation are already incorporated in the CY-2025 Supplemental Investment Program (SAIP) of the Province.

According to him, the PPAs under the Supplemental Appropriation were already incorporated in the CY-2025 Supplemental Investment Program (SAIP) of the province and it was already approved by the Body. To fund the 1st Supplemental Annual Investment Plan (SAIP),

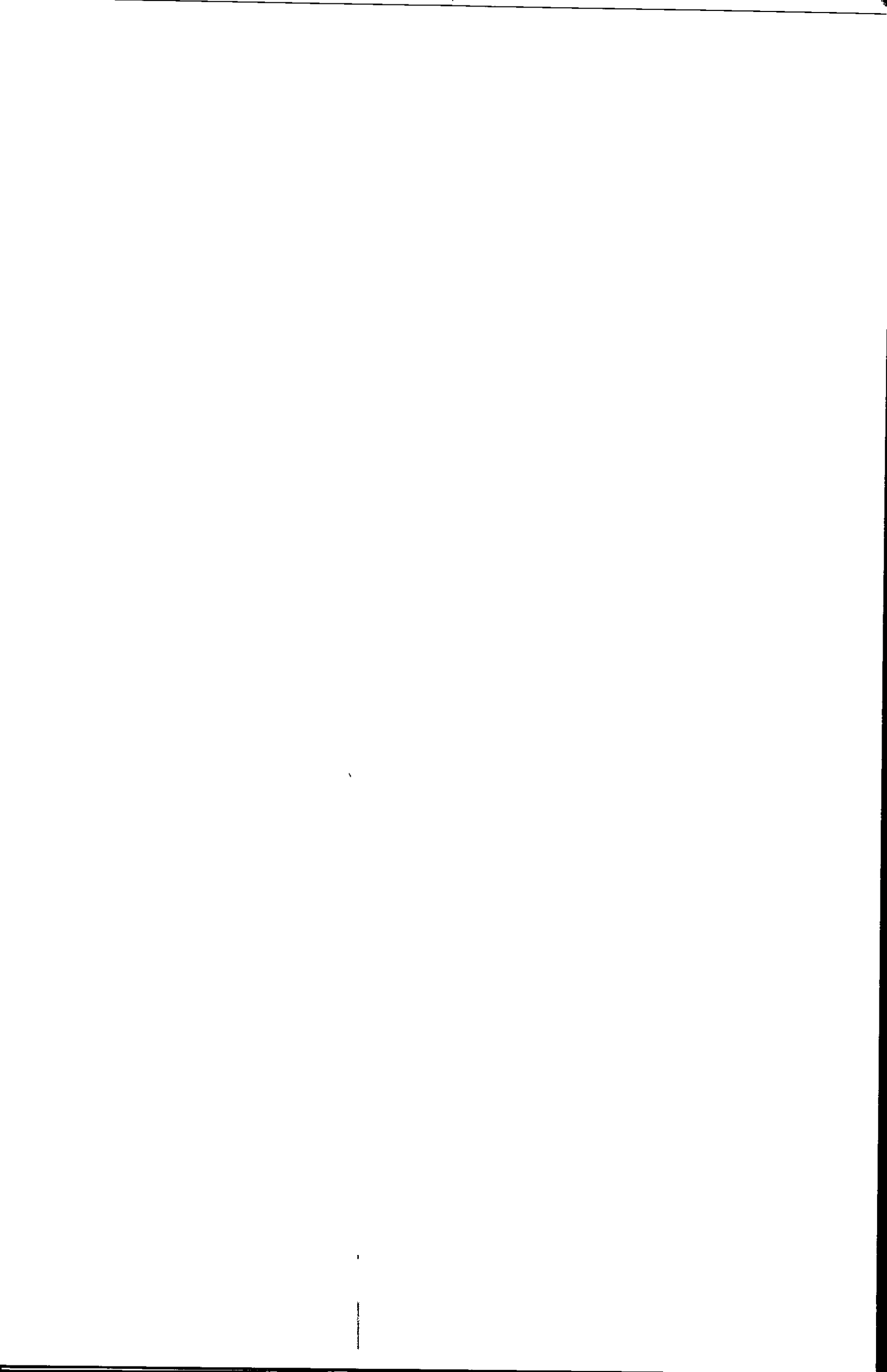
the 1st Supplemental Budget will be passed. He then manifested that an Appropriation Ordinance to this effect be passed in Second Reading in the day's session.

Hon. Sayawan, Sr.'s second concern was to pass a Resolution in Unassigned Business/Privilege Business in the day's session entitled "Concurring and Confirming the Appointment Issued by Hon. Alexander T. Pimentel, Provincial Governor, this Province to Ms. Ana Victoria G. Millan, as Provincial Government Department Head of the Public Employment Service Office (PESO) of the Province of Surigao del Sur".

On the other hand, Hon. Conrad C. Cejoco took the floor during the Privilege Hour. His concern was relative to the development of the Port of Tabon in the City of Bislig. He recalled that few months ago, they requested for the said port to be rehabilitated by the Philippine Ports Authority. He informed the Body that the PPA responded that they will start with the design and planning for the rehabilitation of the said port. To this effect, he manifested to pass a Resolution in Unassigned Business/Privilege Business in the day's session entitled "Earnestly Requesting the Philippine Ports Authority (PPA) – Surigao City to Design the Port of Tabon, City of Bislig as Port to be Utilized by Sea Vessels with 3 Tonnage Capacity and a Drop of 5 Meters". He emphasized that the aforesaid Resolution will be addressed to the Philippine Ports Authority (PPA) Manager to design the Port of Tabon rehabilitation as a port that can be utilized or accessed by the sea vessels with three tonnage capacity and a drop of five meters because the port that was already constructed by the PPA in the City of Bislig is one which can accommodate a larger type of seafaring vessels. According to him, they need a smaller port to accommodate the smaller seafaring vessels, including commercial fishing vessels, so that they have also a port that they be utilized by the aforesaid local government unit.

Hon. Cejoco's second concern was to pass a Resolution in Unassigned Business/Privilege Business in a day's session entitled "Earnestly Requesting the Department of Labor and Employment (DOLE) to Provide the 20th Sangguniang Panlalawigan the Data as to the Unpaid Claims of Various Labor Groups from PICOP Resources Incorporated (PRI) for Possible Intervention in Satisfying the Said Claims in the Liquidation of the Aforementioned Corporation". As per information, the rehabilitation case has already been terminated by the Supreme Court and the said company is under the state of liquidation. He commented that in the said liquidation, they would like to ensure, with the intervention of the local government units concerned, that the claims of those laborers would not be disregarded and by law, it was in fact second only to the claims of the government. He emphasized that they would like to know which labor groups or individuals, still have pending claims which were registered under the rehabilitation case.

This time, Hon. Joseph Anthony P. Cañedo took the floor during the Privilege Hour. His concern was relative to his request of one-storey four-classroom building, at Cambatong Elementary School in Hinatuan, Surigao del Sur to the Office of the Vice President, which was also referred to the Philippine Amusement and Gaming Corporation (PAGCOR) as approved per SP Resolution No. 1864-24, Series of 2024. He informed the Body that the PAGCOR Management already replied to the said request and stated that they are currently in the implementation process of its corporate social responsibility flagship projects. According to him, in his understanding the said request was granted considering the immediate need of the said barangay due to the influx of new enrolled students in the said institution. Along this line, he manifested to pass a Resolution in Unassigned Business/Privilege Business in the day's session entitled "Requesting for a Follow-up from Philippine Amusement and Gaming Corporation (PAGCOR) Regarding the Construction of 1-Storey Four-Classroom Building at Cambatong Elementary School, Hinatuan, this Province as Indorsed by the Office of the Vice President of the Philippines (OVP) Pursuant to Resolution No. 1864-24 Dated April 16, 2024".

The last who took floor was Hon. Antonio C. Azarcon. His concern was relative to the letter-request coming from the Hon. Alexander T. Pimentel, Provincial Governor, this Province dated February 21, 2025 addressed to Hon. Manuel O. Alameda, Sr., Vice Governor thru the Honorable Members of the Sangguniang Panlalawigan, requesting for the urgent passage of the Sangguniang Panlalawigan Resolution authorizing the Provincial Governor to enter into and sign a Deed of Donation, for and in Behalf of the Provincial Government, in favor of the Bureau of Internal Revenue (BIR), represented by Jose Eric C. Furia, Regional Director, covering a parcel of land with an area of One Thousand (1,000) sqm., more or less, being a portion of lot 2763 (33,423 sqm), Cad-392-D TCT No. 161-2023001409 situated at Luha, Rosario, Tandag City, Surigao del Sur and owned by the Provincial Government of Surigao del Sur. He recalled that they already passed a Resolution authorizing the Provincial Governor to represent the province in the Deed of Donation to represent the province, with the Bureau of Internal Revenue donating 2,000 square meters of land for the purpose of building the BIR Office at Luha, Mabua, Tandag, City, this province. However, the Honorable Governor has requested the Body give him another authority to correct the number of square meters to be donated which is 1,000 sqm only. To this effect, he then manifested to pass a Resolution in Unassigned Business/Privilege Business in the day's session entitled "Authorizing Hon. Alexander T. Pimentel, Provincial Governor, this Province to Enter Into and Sign a Deed of Donation for and in Behalf of the Provincial Government of Surigao del Sur in Favor of the Bureau of Internal Revenue (BIR), Represented by Regional Director Jose Eric C. Furia, for the Designation of 1,000 Square Meters Being a Portion of Lot 2763, CAD-392-D Containing a Total Area of 33,423 SQM Titled in the Name of the Provincial Government of Surigao del Sur Under TCT No. 161-2023001409 Located at Sitio Luha, Barangay Mabua, Tandag City, this Province, for the Establishment of the Revenue District Office No. 106 Office Building in Tandag City, this Province".
