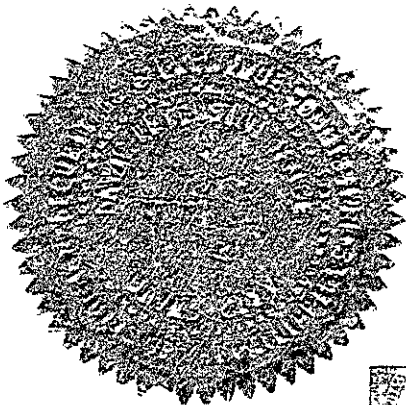
**THIS IS TO CERTIFY** that the Articles of Incorporation and By-laws of
