AFFIRMING ORDINANCE NO. 18 DATED DECEMBER 17, 2024 OF THE MUNICIPALITY OF BAROBO, THIS PROVINCE ENTITLED “ORDINANCE SCRAPPING THE POSITION OF LOCAL LEGISLATIVE STAFF OFFICER I, WITH SALARY GRADE 11, UNDER ITEM NUMBER 5 OF THE PLANTILLA OF PERSONNEL UNDER THE OFFICE OF THE SECRETARY TO THE SANGGUNIAN, SANGGUNIANG BAYAN, THIS MUNICIPALITY”, IT BEING WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN CONCERNED TO ENACT SUCH ORDINANCE PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991

WHEREAS, Ordinance No. 18 dated December 17, 2024 of the Municipality of Barobo, this Province entitled “Ordinance Scrapping the Position of Local Legislative Staff Officer I, with Salary Grade 11, Under Item Number 5 of the Plantilla of Personnel Under the Office of the Secretary to the Sanggunian, Sangguniang Bayan, this Municipality”, was submitted to this Body for review and same was referred to the Committee Good Government, Public Ethics and Accountability, for appropriate action and was indorsed to the Provincial Human Resource Management Office, for technical review;

WHEREAS, Mr. Ace R. Orcullo, MPA, CHRA, Provincial Human Resource Management Officer, this Province in his letter dated February 17, 2025 upon perusal of the subject Ordinance, returned the same with no adverse finding and has recommended for its adoption;
