WHEREAS, during the Privilege Hour of the 129th Regular Session on February 25, 2025, Hon. Conrad C. Cejoco raised concerns regarding the status of untitled properties acquired by the Provincial Government of Surigao del Sur, highlighting their legal and financial implications along with proposed allocation measures, and same was referred to the Committee on Finance and Appropriation (Lead Committee)/Laws and Justice and Human Rights, for appropriation action;

WHEREAS, the absence of formal titling for these properties poses challenges to effective management, legal clarity, and fiscal accountability;

WHEREAS, during the Committee Meeting of the Committee on Finance and Appropriation (Lead Committee)/Laws and Justice and Human Rights held on March 4, 2025 to which the matter was referred to, it was recommended that the Provincial General Services Office (PGSO) be tasked to prepare the Terms of Reference for the titling of the untitled Provincial Government properties;

WHEREAS, the formulation of a comprehensive Terms of Reference is critical to guide the titling process, ensuring due diligence, transparency and proper allocation of responsibilities in addressing the identified issues;
