RETURNING ORDINANCE NO. 2024-04 DATED JULY 23, 2024 OF THE CITY OF BISLIG, THIS PROVINCE ENTITLED “AN ORDINANCE ESTABLISHING A CITY POPULATION OFFICE (CPO) OF THE CITY OF BISLIG, PROVINCE OF SURIGAO DEL SUR, APPROPRIATING FUNDS AND FOR OTHER PURPOSES THEREOF”, FOR RECTIFICATION

WHEREAS, Chapter 3, Article III, Section 468 Par. (a) No. 1 (i) of the Local Government Code of 1991 provides that, “the sangguniang panlalawigan shall review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the sanggunian and of the mayor”;

WHEREAS, Ordinance No. 2024-04 dated July 23, 2024 of the City of Bislig, this Province entitled “An Ordinance Establishing a City Population Office (CPO) of the City of Bislig, Province of Surigao del Sur, Appropriating Funds and for Other Purposes Thereof”, was submitted to this Body for review and same was referred to the Committee on Good Government, Public Ethics and Accountability, for appropriate action and was indorsed to the Provincial Human Resource Management Office, for technical review;

WHEREAS, Mr. Ace R. Orcullo, MPA, CHRA, Provincial Human Resource Management Officer, this Province in his letter dated February 24, 2025 upon perusal of the subject Ordinance, informed the August Body of the following observations, viz:

Section 4 Qualification Standards	The education and training requirements of the position CGDH I (City Population Officer) were erroneously presented in the Ordinance. As presented in the Ordinance under Section 4:	The LGU shall rectify the education and training requirements of the position of CGDH I, pursuant to CSC MC 6, S. 2023, Appendix A-1. It shall be presented as:

	Education: Bachelor's degree relevant to the job Training: Specialized training in population development	Education: Bachelor's degree with specialized training in population development from recognized college or university Training: None required
	The education requirement of the position of Statistician I and Administrative Officer IV (Administrative Officer II) was erroneously presented in the Ordinance As presented in the Ordinance under Section 4: Education: Bachelor's degree	The LGU shall rectify the education requirement of the position of Statistician I and Administrative Officer IV (Administrative Officer II), pursuant to the updated QS Manual provided by the CSC. It shall be presented as: Education: Bachelor's degree relevant to the job

WHEREAS, after a careful deliberation on the matter, the Committee on Good Government, Public Ethics and Accountability, to which the matter was referred to, during its Committee Meeting on March 4, 2024, recommended to return Ordinance No. 2024-04 dated July 23, 2024 of the City of Bislig, this Province for rectification with a suggestion that the same shall adhere to the corresponding observations/findings by the Provincial Human Resource Management Officer, this Province;
