~~AFFIRMING~~ ORDINANCE NO. TC-016 DATED JANUARY 28, 2025 OF THE MUNICIPALITY OF HINATUAN, THIS PROVINCE ENTITLED “AMENDING SECTION 3 OF S.B. ORDINANCE NO. SG-600, SERIES OF 2021, BY INSERTING AN ADDITIONAL CONTRACT OF SERVICE (COS) POSITION UNDER THE HIGHLY TECHNICAL/SKILLED WORKERS CATEGORY FOR THE POSITION OF CONSTRUCTION MAINTENANCE AND GENERAL FOREMAN, WITH A MONTHLY RATE OF ₱20,000.00, UNDER THE MUNICIPAL ENGINEERING OFFICE”, IT BEING WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNIAN BAYAN CONCERNED TO ENACT SUCH ORDINANCE PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991

WHEREAS, Chapter 3, Article III, Section 468, Par. (a) No. 1 (i) of the Local Government Code of 1991 provides that, “the sangguniang panlalawigan shall review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the sanggunian and of the mayor”;

WHEREAS, Ordinance No. TC-016 dated January 28, 2025 of the Municipality of Hinatuan, this Province entitled “Amending Section 3 of S.B. Ordinance No. SG-600, Series of 2021, by Inserting an Additional Contract of Service (COS) Position Under the Highly Technical/Skilled Workers Category for the Position of Construction Maintenance and General Foreman, with a Monthly Rate of ₱20,000.00, Under the Municipal Engineering Office”, was submitted to this Body for review and was referred to the Committee on Good Government, Public Ethics and Accountability and same was endorsed to the Provincial Human Resource Management Officer and the Provincial Finance Committee for their comment and recommendation;
