WHEREAS, Ordinance No. 003 dated February 5, 2025 of the City of Tandag, this Province entitled "An Ordinance Establishing the Guidelines of Monthly Incentives for KALIPI (Kalipunan ng Liping Pilipina) Tandag Federation Officers in Each Barangay of Tandag City, Amounting to One Thousand Pesos (P1,000.00) Per Month, Effective January 2025", was submitted to this Body for review and same was referred to the Committees on Differently Abled or Persons with Disabilities and Senior Citizens, and Social Services and Community Development (Lead Committee)/ Barangay Affairs, for appropriate action;
