Pimentel, Provincial Governor, this Province, in his letter dated February 18, 2025 has requested the August Body of the 20<sup>th</sup> Sanggunian Panlalawigan for the passage of an Ordinance for the proposed additional plantilla position of Nurse I in Bislig District Hospital, City of Bislig, this Province, for implementation in the current fiscal year;

**WHEREAS**, the addition of the position in the plantilla of the hospital assures the people in Second (2<sup>nd</sup>) District of the province of an improved health service delivery and therefore a better quality if life;

**WHEREAS**, finding merit on the above-mentioned request and in view of the foregoing;

**NOW THEREFORE**

**BE IT ORDAINED BY THE SANGGUNIANG PANLALAWIGAN OF THE PROVINCE OF SURIGAO DEL SUR IN A SESSION ASSEMBLED:**

**SECTION 1. Title.** There is hereby created (the) permanent plantilla position of Nurse I, Salary Grade 15 with an Annual Salary of Seven Hundred Eighty Four Thousand Two Hundred Sixty Pesos (P784,260.00) in Bislig District Hospital, City of Bislig, this Province.

**SECTION 2. Qualification Standards** – The Qualification Standards for the following positions shall be as follows:

**NURSE I**

Salary Grade : 15  
Education : Bachelor of Science in Nursing  
Experience : None required  
Training : None required  
Eligibility : RA 1080 (Registered Nurse)

**SECTION 3. Duties and Functions** - That the Duties, Responsibilities and Functions of the position shall be as follows:

**NURSE I, Salary Grade 15**

- conducts an individualized patient assessment, prioritizing the data collection based on the patient's immediate condition or needs within timeframe specified by client's facility policies, procedures and protocols;
- develops plan of care that is individualized for the patients reflecting collaboration with other members of the health care team;
- performs appropriate treatments as ordered by the Physician in an accurate and timely manner;
- documents patient assessment findings, responses to nursing physical/physiological interventions and progress towards problem resolution;
- report's patient condition to appropriate personnel during each shift;
- maintains confidentiality in matters related to patient, family and client facility staff; and
- performs other tasks as maybe assigned by the immediate supervisor.

**SECTION 4. Source of Fund.** The abovementioned position shall be funded wholly out of the Personnel Services of the Provincial Government.

**SECTION 5. Separability Clause.** If, for any reason any part or provision of this Ordinance shall be held to be unconstitutional or ultra vires, the others not so declared shall remain in full force and effect.

**SECTION 6. Effectivity** – This Ordinance shall take effect upon its approval.
