WHEREAS, the Department of Health (DOH) requires all health facilities to secure Environmental Compliance Certificate (ECC) prior to issuance of License to Operate a hospital. However, a Sanggunian Resolution authorizing its Representative to apply for an ECC is a prerequisite;

WHEREAS, the Bislig District Hospital, under the administration of the Provincial Government of Surigao del Sur, is committed to complying with the environmental laws and regulations to ensure sustainable and responsible healthcare operations;

WHEREAS, the Department of Environment and Natural Resources -- Environmental Management Bureau (DENR-EMB) requires an Environmental Compliance Certificate (ECC) for projects that may have an environmental impact, ensuring adherence to environmental protection standards;

WHEREAS, there is a necessity for the Bislig District Hospital to obtain an ECC as part of its compliance with environmental regulations to continue its operations and implement any expansion or improvement projects;

WHEREAS, in compliance thereto, Hon. Alexander T. Pimentel, Provincial Governor, this Province in his letter dated February 18, 2025 addressed to the Honorable Members of the Sangguniang Panlalawigan thru Hon. Manuel O. Alameda, Sr., Vice Governor, all of this Province requested for the passage of a Resolution authorizing Dr. Teresita B. Vicente, Chief of Hospital, Bislig District Hospital, to enter into and sign documents in the application of an Environmental Compliance Certificate (ECC), for and in behalf of the Provincial Government of Surigao del Sur with the Department of Environment and Natural Resources - Environmental Management Bureau (DENR-EMB) Caraga Regional Office;

WHEREAS, Dr. Teresita B. Vicente, Chief of Bislig District Hospital, is in the best position to represent the hospital and the Provincial Government of Surigao del Sur in matters related to the ECC application and compliance with DENR-EMB requirements;

WHEREAS, granting authority to Dr. Teresita B. Vicente to enter into and sign the the documents in the application of an ECC on behalf of the Provincial Government of Surigao del Sur will facilitate the efficient processing and approval of the required certificate;

BE IT RESOLVED by the Sangguniang Panlalawigan of Surigao del Sur to authorize Dr. Teresita B. Vicente, Chief of Hospital, Bislig District Hospital, Bislig City to enter into and sign the application of an Environmental Compliance Certificate (ECC), for and in behalf of the Provincial Government of Surigao del Sur with the Department of Environment and Natural Resources-Environmental Management Bureau ((DENR-EMB), Caraga Regional Office, Butuan City.
