WHEREAS, maintaining cleanliness and sanitation is essential for public health, environmental protection and the overall well-being of communities, contributing to sustainable development and resilience against health hazards;

WHEREAS, Local Government Units (LGUs) and Barangay Officials play a vital role in implementing environmental and sanitation policies within their respective jurisdictions, making their participation essential in the success of the "Kalinisan sa Bagong Pilipinas Program";

WHEREAS, the Provincial Government of Surigao del Sur recognizes the importance of enjoining all LGUs and their respective Barangays to institutionalize the "Kalinisan sa Bagong Pilipinas Program" to ensure the systematic and long-term implementation of cleanliness and sanitation initiatives across the province.

WHEREAS, the 20th Sangguninang Panlalawigan Members, this Province adopted Resolution No. 2822-25 dated February 4, 2025¹³⁻²⁵ entitled "Earnestly Requesting the Provincial Environment and Natural Resources Office (PENRO-LGU) to Make Recommendations for the Institutionalization of the Kalinisan sa Bagong Pilipinas Program in the Province of Surigao del Sur" pursuant to Memorandum Circular No. 2024-059 of the Department of the Interior and Local Government (DILG);

WHEREAS, Mrs. Thelma S. Alcoberes, RF, Provincial Environmental and Natural Resources Officer, this Province, in her letter dated February 25, 2025, addressed to the Sangguniang Panlalawigan Members, this Province submitted her recommendations for the above-mentioned Resolution and same was referred to the Committees on Environmental Protection & Ecology (Lead Committee)/Finance and Appropriation for appropriate action;

WHEREAS, enjoining all LGUs and Barangay Officials to actively participate in the said program will enhance public awareness, strengthen community involvement, and contribute to a cleaner and healthier environment across the province. The support and participation of local government units, private sectors, and civil society organizations are crucial in sustaining and expanding the impact of the program throughout the province;

WHEREAS, after a careful review by the Committees to which the matter was referred to, it was found out that it is within the ambit of the provisions of the Local Government Code of 1991;
