TC-019 DATED FEBRUARY 4, 2025 OF THE MUNICIPALITY OF HINATUAN, THIS PROVINCE ENTITLED "ORDINANCE CREATING THE POSITION OF ADMINISTRATIVE AIDE III (UTILITY WORKER II) WITH SG-03 OF THE MUNICIPAL ECONOMIC ENTERPRISE AND DEVELOPMENT OFFICE", IT BEING WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNIAN BAYAN CONCERNED TO ENACT SUCH ORDINANCE PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991

WHEREAS, Chapter 3, Article III, Section 468, Par. (a) No. 1 (i) of the Local Government Code of 1991 provides that, "the sangguniang panlalawigan shall review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the sanggunian and of the mayor";

WHEREAS, Ordinance No. TC-019 dated February 4, 2025 of the Municipality of Hinatuan, this Province entitled "Ordinance Creating the Position of Administrative Aide III (Utility Worker II) with SG-03 of the Municipal Economic Enterprise and Development Office", was submitted to this Body for review and was referred to the Committee on Good Government, Public Ethics and Accountability and same was endorsed to the Provincial Human Resource Management Officer for his comment and recommendation;

WHEREAS, Mr. Ace R. Orcullo, MPA, CHRA, Provincial Human Resource Management Officer (PHRMO), this Province, in his letter dated March 6, 2025 upon perusal of the said Ordinance, returned the same with no adverse finding and has recommended for its adoption;

WHEREAS, after careful review by the Committee to which the matter was referred to, it was found out that it is within the ambit of the provisions of the Local Government Code of 1991;
